VRMC Update April 2025

04/07/2025

I picked up a copy of the current Nueces County Voter Roll on 04/08/25 to compare the 83 year old deceased voters and the recently deceased voters from 03/2025. We had 42 out of 42 of the 83 year old deceased voters and 47 out of the 168 recently deceased voters identified left that after the comparison that were presented to Mr Ralph Benavides at the Voter Registrar's office on 04/09/25. Mr Benavides was interested in how they were doing on addressing our submissions. He said moving forward he would try to get a notation on any spreadsheet we submitted if there was a rejection.

We have submitted a total of 883 deceased Voters to be removed from the Voter Roll.

We also submitted a total of 17 Voters to the Voter Registrar's office that have moved out of state, (6 to Florida, 5 to Georgia, and 6 to North Carolina), who have re-registered and most have voted in those states.

04/14/2025

I requested a database table definition file from Mr. Alex Perez at the Voter Registrar's office and he sent it the next day. This file lists all the columns defined in their database and their descriptions and defined entries so we can include other information on the downloads we receive from them.

I have emailed our County Clerk, Ms Sands, again requesting the report of voters that surrendered the Vote By Mail ballots for the 11/05/24 General Election. I stopped by the County Clerk's office on 04/08/25 and Ms Sands was not in at that time so I ask Diana Munguia, Elections Manager, to remind her I still need the list of VUID #'s. I stopped by again on 04/09/25 after leaving my meeting with Mr Benavides and Ms Sands was in the office but she was going to court. I asked Diana to see if Ms Sands still had the report and could she just cut off the VUID #'s and give them to me and she did. The data appears to be confirming our suspicion that the SOS is not doing it's due diligence in cleaning up their database of entries made for tracking Mail In Ballots. The current count of Nueces County voters that show they voted multiple times in the same election is now 343, that includes a total of 281 of the 329 voters supplied from the County Clerk's office for the 11/05/2024 election.

04/28/2025

We have submitted a total of 883 deceased Voters to be removed from the Voter Roll.

We currently had identified 84 recently deceased voters for the month of 0425. We have identified 23 registered voters for the age group 82. We have completed 8 of the 13 sections with 4 sections assigned and 1 waiting.

I have emailed Mr. Perez in the Voter Registrar's office requesting all available database entries on 4 Voters that show to have voted 3 times in the 11/05/24 election all with multiple VBM entries. I will request the same info from Ms Sands in the County Clerk's office, after the current election, including dates when the VBM request was made, when it was sent, when the SOS was notified, if it was rerequested, the date canceled and resent, the data the SOS was notified again, how the final vote was cast. The current count of Nueces County voters that show they voted multiple times in the same election is now 350. Again these are NOT multiple votes being cast, this is an SOS database issue and their lack of due diligence in cleaning up their database entries for tracking Vote By Mail Ballots.
