

VRMC Update June 2025

06/02/2025

I held another VRMC training session on Wednesday 05/14/2025 with our newest member Ms Carrie Ann Campbell.

We have completed all of the 81 year old sections. We have identified 31 81 year old deceased voters and 118 recently deceased voters. I requested up a copy of the current Voter Roll on 06/02/2025

We have submitted a total of 979 deceased Voters to be removed from the Voter Roll.

The current count of Nueces County voters that the SOS shows they voted multiple times in the same election is now 391. Again these are NOT multiple votes being cast, this is an SOS database issue and their lack of due diligence in cleaning up their database entries for tracking Vote By Mail Ballots.

On 05/06/2025 I finally received the actual downloaded raw data from the SOS, but just for Nueces County, from Todd Lindstrom with TPA showing 311 multiple entries for the 11/05/24 General Election in Nueces County. The data shows exactly what we expected with multiple lines for each of these voters. Their voting type show either EV (Early Vote), ED (Election Day), or AB (Absentee). On 05/07/2025 I stopped by Kara Sands office to check on their progress with the data I had requested and brought a printed copy of the request. I mentioned that I had finally received the actual SOS data and mentioned the vote type listed was AB (Absentee). On my request the Voter history designation in TPA said "Voted By Mail". Ms Sands informed me that was an incorrect designation and that AB in the SOS database only means that an Absentee Ballot was requested. It does not mean they actually "Voted By Mail". The data that is sent to the SOS are only "Requests for ballots" for Absentee, daily check-ins on Poll Pads for Early Voting, and check-ins on the Poll Pad for Election Day – NOT actual votes cast. The actual votes cast are kept at the County level in their database. This means that SOS Voter Data cannot be used to track actual votes especially Vote By Mail, only the County data can be used.

06/09/2025

We have completed all of the 15 81 year old sections. I requested and received a copy of the current Voter Roll on 06/02/2025 from the Voter Registrar's office. We had 31 out of 31 81 year old deceased voters and 68 out of 145 recently deceased voters left after the comparison. They will be presented to Mr. Benavidez at the Voter Registrar's office on 06/11/2025.

We have submitted a total of 1078 deceased Voters to be removed from the Voter Roll.

The current count of Nueces County voters that the SOS shows they voted multiple times in the same election is now 391. A PIR was drafted to send to the SOS showing our findings, requesting conformation of our assumptions, requesting the data be corrected and procedures changed to keep this from occurring in the future, and requesting a meeting with the SOS to discuss this issue. This letter was copied and sent to our local Representatives Todd Hunter and Denise Villalobos, and our Senators Adam Hinojosa and Juan "Chuy" Hinojosa, 89th legislature Elections Committee Chairman Matt Shaheen and 89th legislature Elections Committee Vice-Chair John Bucy III requesting their help in setting up this meeting.

I requested and received a copy of the current Voter Roll on 06/23/2025 from the Voter Registrar's office. We still had 31 out of 31 81 year old deceased voters and 15 out of 145 recently deceased voters left after this comparison. They will be presented to Mr. Benavidez at the Voter Registrar's office later this week.

We have submitted a total of 1025 deceased Voters to be removed from the Voter Roll.

On June 16th the EIP board had a meeting with Representative Todd Hunter to discuss our Multiple Vote Method entries in the SOS data and ask if he could set up an in-person meeting with SOS personnel to discuss this issue.
