

VRMC Update May 2025

05/12/2025

I held another VRMC training session on Thursday 05/01/2025 with our new member Ms Rachel Reyes. We went over the remainder of the training from the last training session and worked through several examples.

The Voter Registrars office progress on the previously submitted items are listed below.

We had 29 out of 34 82 year old deceased voters and 67 out of 95 recently deceased voters left after the comparison that was presented to Mr. Benavidez at the Voter Registrar's office 05/05/2025. We resubmitted the 9 recently deceased from 0225 and the 25 previously deceased from age group 84.

We have submitted a total of 979 deceased Voters to be removed from the Voter Roll.

We have completed 5 of the 15 81 year old sections with 5 sections assigned and 5 waiting. We have identified 8 deceased 81 year old voters so far and 46 recently deceased voters for the month of May.

I received an emailed Mr. Perez in the Voter Registrar's office requesting on 04/29/2025 with all available database entries on the 4 Voters that SOS data shows to have voted 3 times in the 11/05/24 election all with multiple VBM entries. There was only 1 entry for each of the 4 in the Nueces County Voter Roll.

I requested the same info from Ms Sands in the County Clerk's office on 05/05/2025, including dates when the VBM request was made, when it was sent, when the SOS was notified, if it was re-requested, the date canceled and resent, the date the SOS was notified again, when and how the final vote was cast. The current count of Nueces County voters that show they voted multiple times in the same

election is now 362. Again these are NOT multiple votes being cast, this is an SOS database issue and their lack of due diligence in cleaning up their database entries for tracking Vote By Mail Ballots.

On 05/06/2025 I finally received the actual downloaded raw data from the SOS, but just for Nueces County, from Todd Lindstrom with TPA showing 311 multiple entries for the 11/05/24 General Election in Nueces County. The data shows exactly what we expected with multiple lines for each of these voters. Their voting type show either EV (Early Vote), ED (Election Day), or AB (Absentee). On 05/07/2025 I stopped by Kara Sands office to check on their progress with the data I had requested and brought a printed copy of the request. I mentioned that I had finally received the actual SOS data and mentioned the vote type listed was AB (Absentee). On my request the Voter history designation in TPA said "Voted By Mail". Ms Sands informed me that was an incorrect designation and that AB in the SOS database only means that an Absentee Ballot was requested. It does not mean they actually "Voted By Mail". The data that is sent to the SOS are only "Requests for ballots" for Absentee, daily check-ins on Poll Pads for Early Voting, and check-ins on the Poll Pad for Election Day – NOT actual votes cast. The actual votes cast are kept at the County level in their database. This means that SOS Voter Data cannot be used to track actual votes especially Vote By Mail, only the County data can be used.
