#### **Website Terms and Conditions of Use**

#### 1. About the Website

- 1. 2. The Website is operated by Wipe Cleaning Services (ABN 28285170894). Access to and use of the Website, or any of its associated Products or Services, is provided by Wipe Cleaning Services. Please read these terms and conditions (the 'Terms') carefully. By using, browsing and/or reading the Website, this signifies that you have read, understood and agree to be bound by the Terms. If you do not agree with the Terms, you must cease usage of the Website, or any of Services, immediately.
- 1. 3.Wipe Cleaning Services reserves the right to review and change any of the Terms by updating this page at its sole discretion. When Wipe Cleaning Services updates the Terms, it will use reasonable endeavors to provide you with notice of updates to the Terms. Any changes to the Terms take immediate effect from the date of their publication. Before you continue, we recommend you keep a copy of the Terms for your records.

# 2. Acceptance of the Terms

You accept the Terms by remaining on the Website. You may also accept the Terms by clicking to accept or agree to the Terms where this option is made available to you by Wipe Cleaning Services in the user interface.

#### 3. Registration to use the Services

- **3. 1.**In order to booking the Services, you must first register your information through the Website.

- **5. 3.**You acknowledge and agree that where a request for the payment of the Services Fee is returned or denied, for whatever reason, by your financial institution or is unpaid by you for any other reason, then you are liable for any costs, including banking fees and charges, associated with the Services Fee.
- **5. 4.**You agree and acknowledge that Wipe Cleaning Services can vary the Services Fee at any time .

### 6. Refund Policy
