News From the Property Manager (Sophia Reeves)



Pool:

Please sign in (Owners and guest).

Pool Heater:

The heater to the pool has been shut off pending the invoice from 5/30/2023 for the propane fill up which was 1,015.90 gallons. Once the invoice has been received, it will be sent over to the Board of Directors for review and cost analysis, and then an email of this cost will be sent out to all unit owner(s). Please note, the cost to heat the pool was not included in with the 2023 budget due to it was just completed this year and will need historical data for the 2024 budget.

Pool Gate:

To prevent liabilities, please ensure the gate is closed after you exit the pool. During the 2nd week of July there will be an emergency push button installed on the inside of the gate.

Pool Passes for Guest:

Please email sreeves@danellarealty.com to schedule a time to pick up the guest passes. Again, you must have the guest waiver filled out and signed by all parties before picking up your passes. If I'm not in my office do to meetings or inspections, please slide under my office door.

Game Room:

The new ping pong table is in route and scheduled to arrive by end of June 2023.

Fitness Room:

Please sign in and out on the clipboard provided. **Only unit owner(s) and permanent residents can use the fitness room.** Please do not allow your guests to utilize this area at anytime due to liability risk, and ultimately there will be 252 homes that would like to enjoy this amenity. Thank you for your understanding and cooperation.

Courts:

The vendor for the developer will be out to make some necessary repairs at the courts by mid-July.

Trails Update:

Although the trails are not 100% completed (e.g. weeds, signs, gravel), the developer has confirmed that homeowners are ok to walk on them at their own risk.

Settlements:

Currently there are 115 settlements and another 12 are pending with a total of 127 by end of August 2023, and projected settlements are 143 by end of December 2023. NV Homes' plan is to sell 252 homes by end of 2026. The Association will remain under the developer's (RLD) control until the community achieves 189 settlements (75%), and if there is no delays with upcoming settlements, the projected transition election for homeowners to take over the board is mid-end of 2025.

Out of Office:

I will be out of office as of 30 June through the 4th of July Holiday and will return on July 5th. If you have an emergency during this time please call (610) 834-6200.

Please note, since I do manage both the Woodlands 55+ and Greystone communities (two separate Associations), I'm scheduled to be on-site 9am-5pm M-F but just in case I'm in a meeting or completing an on-site inspection, I'm always available via email sreeves@danellarealty.com. Good news! Once Woodlands at Greystone reaches 200 settlements another person will join me on-site.

If you are using one of these contractors for your work, you can reference the COI on file when submitting your Exterior Alteration Request rather than attaching the COI.

The Social Committee had a general meeting on Thursday, June 22. At the meeting we announced the reorganization of the Social Committee. Instead of subcommittees we now have the following workgroups: Activities, Clubhouse/Pool, Communication, Courts, and Sunshine. Each workgroup has a vice chairperson responsible for tasks that are assigned and will call on workgroup members to assist with those tasks. When the workgroup has recommendations, the entire social committee will vote on them. All voting members must have a signed code of ethics on file and be active in at least one workgroup. However, anyone is welcome to attend the general meetings and contribute to the committee as we are always looking for assistance.

At the meeting we also discussed the rules and procedures that have been established. Most of the rules and procedures have been put in place for safety reasons and to protect the HOA. No one wants a large assessment at the end of the year. The committee is comprised of volunteers that make decisions that are good for the whole community and are based on research of other communities such as ours. We recognize that there may be changes needed to the procedures but we need some history before doing this. 

Clubhouse / Pool (Judy Malkus)



It has been great to see so many residents enjoying the pool facility and building relationships with their neighbors. With the dog days of summer upon us, that will mean even more pool activity.

One important note to keep in mind is to remind guests to bring their own chairs, especially on busy weekends and holidays. There is a limited number of chairs on the pool deck which should be made available to residents.



The newly implemented seasonal guest pass policy will help to streamline the process for inviting guests. All residents and guests must sign in upon arrival and have a waiver of liability on file. There are always blank copies of the waiver available on the sign-in table if needed.



Do you feel like you have left something behind? There is now a “Lost and Found” bin in the copy room. See the manager on duty to check if your lost belongings have been found. Likewise, dishes are sometimes left behind when there are social functions. These will be held for an additional two weeks before becoming property of the clubhouse.



One last reminder. Pets are not permitted in the clubhouse, on the pool deck area, within the pool itself or on the courts. The only exception is a guest or resident that requires a service animal. That service animal must have all updated vaccinations. We appreciate your adherence to this policy.


