News From the Board (Gene Goldman)

Trails:

I recently had the opportunity to meet with the developer's legal firm responsible for the community's Declaration, original Rules and Regulations, and Bylaws. I discussed with the responsible attorney the continuing concerns of some owners about the public using trail #26 which passes very close to the rear living area of a number of homes as it winds around from Aram to Sculthorpe. Although the former Township engineer was firm in his position that the trails in Woodlands were designated as public, Bill Reiser recently informed me that to the best of his knowledge, Neighborhood Improvement District bond funds (NID) were not used for development of those trails and so should be marked as private to the adult community. In my discussion with his attorney, I asked her to take my request for another reconsideration to the Township solicitor and she agreed to do so. The good news is that the solicitor agreed that trail #26 could be closed to the public. She approved the HOA to put up signage at the Aram entrance stating "No Public Access" or words to that effect. Signs will be ordered for installation. However, the solicitor was clear that trail 26 could not be realigned or relocated as some have suggested - it has to remain as shown on the approved land development plans.

The status of trail #24 is likely to have a similar status outcome (it hasn't been built yet - it is part of the final phase of development). As for Trail #25, discussions between the attorneys are continuing. A similar process is happening over in the Greystone HOA with the developer's attorney meeting with the Township solicitor to discuss the status of their spur (access) trails within those communities also being declared private. Most of the trails within the boundaries of the Greystone HOA will remain public since they were developed with NID funding but the access trails connecting those public trails to sidewalks and roads within the towns, twins, and single family home communities were not built with NID funding.

Board Meeting Minutes:

At the April 25th Executive Board (EXBO) meeting, I was appointed as the Board Secretary. In that role, I will prepare the board meeting minutes. The April minutes are awaiting the Board President's approval for posting on the Danella web portal for owners to view. Unfortunately, until that happens, I am not able to summarize them for this newsletter. The minutes will be posted as soon as Bill Reiser signs off on them. For future quarterly EXBO meetings, they will be held at the beginning of the month so that the minutes can be prepared and approved prior to the following month's newsletter where I will provide a summary and a link to the document.

HOA (Developer-Controlled vs. Owner-Controlled):

From the many calls, emails, and meetings Sophia and I have had with residents, it became apparent to us that for many of our owners, Woodlands is the first HOA they are lived in, at least as a primary residence. And even for HOA-savvy folks, the many differences of a developer-controlled HOA versus an owner-controlled one are new to them.

I started to write a basic primer on those differences along with explanations of the jumble of terms that apply to Woodlands homes such as common area, limited common area, limited common facility, building envelope, plot lines, the differences and linkages between builder/developer/HOA responsibilities, land development plan, conditional use approval, impervious coverage limits and more, and how all of that impacts exterior alteration requests and other personalization of lots. I soon realized that it's a discussion best had in a live Zoom call. So the next quarterly HOA Owner's zoom meeting will feature that discussion.

Sheila and I will be away from mid-June to mid-July traveling crisscrossing the country to visit family so there will not be a board report in the July newsletter.

News From the Property Manager (Sophia Reeves)



Courts:

There is now a trash can for your convenience and it's emptied every Thursday by the cleaning vendor (MD Clean). Please email sreeves@danellarealty.com if you see any future damages.

Pool:

The pool fob system is complete and you must use your fob in order to gain entry and again when exiting the pool area. American Pool will be out M-W-F late afternoon to clean, test and add chemicals. Additionally, HOA Board of Directors have approved an additional cost of \$4200 to have the pool water tested daily and will keep a log of the results for the health inspector. We appreciate your cooperation when there is a need to exit the pool for cleaning and/or if chemicals are being added. Currently, the pool water is heated at a comfortable 78 for the next couple of weeks to get a cost for heating and once the bill is received, it will be sent up to the Board for final review.

MD Cleaning Vendor will commence with cleaning of both locker rooms starting June 1st 2023 and will complete cleaning every Thurs, Sat and Monday.

Pool passes are ready to be picked up M-F 10am-4pm and guest may now start using the pool with a unit owner or permanent resident starting June 1st 2023 and passes are available M-F from 10am-4pm. Please note, M-W are for daily passes and Thurs/Friday are for weekend passes so please plan accordingly and all guest must come through the front door and sign in with unit owner/permanent resident.

Please be careful when walking on the wet floors.

Fitness:

Please read the rules on the right side of entry door and sign in when using the facility as this way, the committee has a projection of how many people are actually using this area. Additionally, to avoid the censor lights from turning off please turn on the light switch which is located under the AED box and please turn if off when leaving. Please report any damages to the manager.

Clubhouse Access:

If you still have not received your fob (s), please email me sreeves@danellarealty.com to schedule an appointment.

Front Gates:

This project was pushed until end of development due to the construction trucks need to use Bollinger access. The projected completion is end of 2025 or mid-2026.

Parking Rules Enforcement and Fines:

As a reminder, parking fines commence June 1st 2023 and for those that are unaware of the rules, you can locate them on the Danella website or email me for a copy that was mailed to all unit owners via 3rd party mailing. Please note, you must obtain a guest pass for any visitor or vendor that is going to utilize the guest parking areas for more than 72 hours. You can get a parking pass by contacting me at sreeves@danellarealty.com.

Settlements:

The NV Homes sales team are selling and currently, there are 123 settled homes. Please note, the goal is for homeowners to take control of the board and once a total of 189 settlements (75%) is reached then a transition election will be held within 60 days seeking candidates to fill five board seats.

This is where you can find all upcoming events, card games, court activity, yoga, book club and so much more. Additionally, you are able to see when the clubhouse and pool locker rooms are being cleaned and also, if I'm in or out of office due to major holidays, vacation time or if I'm at a mandatory management or in training.

Architectural Review (Dave Prilutski)

Please remember to use the Exterior Alteration Request form dated 1/10/23. You must sign on page one and initial all 6 pages to confirm you have read and will comply with the requirements. The form is available on the community website and on the Danella site. Please make sure the contractors' certificate of insurance identifies The Woodlands as the certificate holder. We've had to return several requests to homeowners to correct these areas and this can delay your project. We do accept typed signatures and initials on the form. You can also email us with questions about your proposed project before you go through the steps of completing the form.

Through May we have processed 33 requests. The average time from request to HOA Board approval has been 7 days. Simple requests, such as handrails and bird/vent guards are usually approved in one or two days. More complex projects, such as patios, typically require 14 days from request to Board approval but have taken as long as 30 days.

<u>Landscape & Grounds (Anne Stanley)</u>

The subcommittee has been working to define requirements for the Rockwell Propane Tank Farm improvement project to improve the overall appearance of the farm and to screen the tank heads and distribution box. We reviewed recommendations from several landscapers along with committee members' inputs. We will be getting bids from three vendors and expect to implement the project in the fall.

Shearon met with the entire subcommittee in May and addressed many issues and concerns related to mowing, edging, fertilizer and turf treatments, soil sampling and bald spot remediation. Carol Bourrie discussed her personal soil sample results in depth along with the recommendations provided. We plan to participate with Shearon in a 'walk-around' review in June to assess general landscape status and issues. In addition we will continue to have monthly meetings with Shearon to provide performance feedback.

The subcommittee's near-term focus is on the upcoming 2024 maintenance contract, which will be the main topic for our June meeting.

Thanks to those who have used the mailbox, and please plan to check the website as we are continuing to update the Landscape and Grounds section with additional information for all homeowners on a regular basis.

Many new residents have joined the community, so we would like to take this opportunity to go over some general pool and pool deck guidelines.

- Please remember to enter through the main clubhouse doors and sign in at the table located next to the on-site manager's office. Exit through the outside pool gate.
- If you have not already done so, make an appointment with the on-site manager to pick up your resident pool pass.
- NO GLASS! (this includes beverage bottles). All beverages must be in a CLOSED container. No food in or around the immediate pool and hot tub areas.
- Please be mindful of others relaxing by the pool as well as specified hours for residents only and children.
- Clean up the area upon leaving. If you move furniture, please take a moment and move it back. This is appreciated by your fellow neighbors and HOA staff.

GUEST POLICY

- Two guests per unit and guests must always be accompanied by a homeowner or permanent resident regardless of age.
- Guest passes are assigned by the on-site manager and returned to the drop box when exiting the pool. There is a \$10 replacement fee if not returned.
- Guests are to sign in upon each visit, have a Waiver of Liability on file, and wear a guest wristband.

Please take time to review all the pool and hot tub guidelines and protocols to ensure a respectful summer pool season.

POOL HEATER

The pool will be heated for the first few weeks at which time heating costs and need for heating will be evaluated. With the summer days getting warmer and the night time temperatures not dropping too low, we are optimistic to be able to maintain a desirable water temperature.

POOL SIGN IN

It is very common for community pools such as the YMCA, ACAC and various country clubs to have sign-in procedures and rules similar to ours. The purpose is primarily for safety as it is important to track who is on the premises. Sign-in is also used to track usage. If we want to continue to enhance the pool area with additional furniture and amenities, this gives us data to determine if the usage warrants the improvements. Thank you for understanding.


