Greetings from the Woodlands HOA Board of Directors!

There soon will be additional developer activity in Phase One of Woodlands, which comprises all of Rockwell, Wyeth, and Sculthorpe up to the model homes.

1) Top coating of the streets: the plan is to begin top coating in October. Prior to that, construction damage and other wear and tear deterioration of the curbs, driveway depressions, and streets will need to be remediated. That process has already started. Specific owners impacted by driveway depression (the continuation of the curb that slopes in front of the driveway apron) repair activity will be notified in advance so they can relocate vehicles as needed (not all owners will be impacted by this). Owners in Phase One will receive specific instructions on driveway access and driving on the affected streets before the top coating process begins. As soon as the top coat project is completed, the plan is to shift all construction traffic to enter Woodlands only through the Bollinger entrance.

2) Activation of Sculthorpe Entrance Gates: Sometime after the completion of the Phase One top coating project, the entry gates on Sculthorpe will be made active. RLD has put out a request for bids for the project that will entail adding actuation motors to the gates and the purchase of electronics for distribution to the owners for use in their vehicles to enter/exit the community. There will be a pin pad installed in the pull-off by the entrance for delivery and service vehicles as well as visitors to use. The Parking and Streets Committee has been asked to advise the Board on this project as more details become available.

3) Mailbox Relocation: The Wyeth Lane set of mailboxes will be relocated directly across the street thus restoring one of the overflow parking spaces (which is currently marked "No Parking"). The concrete pad has been poured as has been the sidewalk access strip from the street.

4) **Clubhouse Progress:** As all can see, the sun deck addition construction project has been moving along. The plan remains on track to open the clubhouse to owners by the end of October. The pool and hot tub will be ready for use in the Spring. The Clubhouse Rules and Regulations are undergoing a final revision and I will share a copy with the Social Committee for comments, suggestions, and final edits before distributing to owners.

5) Trail 25 & 26 Updates: Trail 26 is the trail behind the homes on Sculthorpe that winds around to Aram. It is scheduled for refurbishing this Fall. Trail 25 runs behind the homes on Wyeth and also terminates in Aram and is slated for a 6' high wood fence to be installed in October after the trail's drainage slope and gravel renewal is completed. The fence will be on the homes side of the trail and will have two entry gates (locations tbd) for owners to be able to access the trail. Trail 24 will be constructed in Phase 4 of Woodlands. The Landscape and Grounds Committee will be asked to advise the Board on the maintaining and beautifying the trails within Woodlands. The HOA is responsible for maintenance of all trails located in Woodlands.



6) **Remediation of Calcium Pellet Damage**: Danella Management is working with John Balascio, the snow removal contractor from the 21-22 season, to repair the grass damage for the homes that sent in photos. This is the best time of year to seed &/or lay sod so Danella is working with him to schedule the repairs.

7) Fall Planting at the Entrance Roundabout: Shearon has received the plantings slated for the roundabout by the Sculthorpe entrance and will be switching out the summer flowers for the fall ones. Deer resistant varieties were selected. That's all for now.

### Parking & Streets (Andre)

The first meeting of the Parking and Streets Committee took place on September 16th via Zoom and in person at the home of Andre Bourrié and the committee members discussed several topics related to the Charter of the Committee. Minutes of the meeting once approved, will be published on the HOA website. Motions were made and adopted to rename all overflow parking spaces " guest parking spaces" and to allow guests to park in any available such space for up to 72 hours without the need to have their cars registered with the HOA.A friendly reminder was made for the residents to complete or update the Automobile information of the "owner information" form given to The Woodlands Community Association who mails it with their welcome letter and the login to the HOA website upon settlement of the owner's home. The HOA request for exterior alteration form will be updated to include information of the contractor's vehicle(s) used to provide services to the requesting resident. Residents may also have noticed the work in progress to relocate the bank of mailboxes at the top of Wyeth to the other side of the street, right next to the existing walkway. This will free up another much needed guest parking space there. Please check the HOA calendar for any follow-up meeting of the Parking and Streets Committee.

The first committee meeting was held on 9/14 with several homeowners in attendance. There was general discussion about the committee charter and Gene was able to provide some input on activities he's been working. He requested that the committee review and provide any suggested changes to the Landscape schedule. ### Social (Dyanne / Linda)

The Social Committee has been very busy this month. The following subcommittees have been established and the leads are moving forward on their agendas.

- Activities (Lead TBD) The Activities Subcommittee met on September 11 and created a list of exciting activities for the community. Some activities need to wait until the clubhouse is open but that did not stop us. We have scheduled the following: Poker Night on Thursday, October 6, Halloween House Crawl on Friday, October 28 and Book Club on Thursday November 3. Details about activities will be shared through our community newsletter, Facebook Group and Danella Portal.
- Clubhouse/Pool (Judy Malkus) The first meeting of the sub-committee was held on September 20. In attendance were co-chairs Linda McElvenny and Judy Malkus along with members Janet Melton (secretary), Anne Stanley and Joanne Ritchie. We reviewed the floor plans and lists of furniture and equipment. Clarification was made on the design of the kitchen which has been established as a "catering' kitchen. There is no oven or stove and the expectation is to use food trays with sternos. There is a refrigerator and dishwasher. As you can imagine, there are many questions still to be answered regarding clubhouse access, booking apps, budgets, and management, to name a few. Pool discussions, as well as grilling areas, are on hold for now until we launch the much-awaited completion of the Clubhouse. Established rules and regulations are being reviewed and will be communicated once they are completed.

- Clubhouse/Pool (Judy Malkus) Continued The sub-committee will work hand-in-hand with the Activities Sub-Committee regarding the opening of the clubhouse which is still slated for late October. Once opened, residents will not be able to rent/use the facility for private parties. Once we get the general processes and policies ironed out for the opening, we will take this on. Additionally, the parking lot cannot be used for activities until it is turned over to the HOA from the developer. Know that the mission of this sub-committee is to address your concerns, answer your questions, and provide updated information which, in turn, will create an exciting new facility for our community to come together! - Courts (Linda McElvenny) The Courts are now available for play on a first come first served basis. We have 1 tennis, 2 pickleball and 2 bocce courts. The tennis and pickleball courts are locked and the code for access is 1150. We are reviewing an online court reservation application and decided to wait until the spring for further review and implementation. If someone is waiting, please limit play to 90 minutes. The court rules have been posted so please be mindful of them. We have identified some enhancements and have submitted them to the builder. He has agreed to install benches which is currently underway. Any capital improvements to the court area would require HOA budget approval.
- Communication (Tim Owens) Dave and I are excited to produce the second edition of our community newsletter. We hope you are enjoying it. The West Goshen Township Board of Supervisors approved a Resolution designating a 25 MPH speed limit on Aram Avenue and authorizing enforcement of traffic regulations on that still private connector, by the West Goshen Police Department. This action was taken to resolve an issue related to school bus access on Aram Ave. Please note the new posted speed limit.

### Greystone Hall Plans Shared with Community



The Jerrehian family hosted an open house at Greystone Hall to inform the community of their revitalization plans. Many residents of The Woodlands attended but for those who didn't here's a quick synopsis. The Jerrehian family has owned Greystone Hall since 1942. They are currently investigating a sale of the property and are targeting parties interested in turning it into a luxury hotel. This would require a zoning change. It's in the very early stages but they have hired outside advisors who depict a 60 room hotel with some new outbuildings and a plan to convert the Carriage House (visible from Aram) into a Café style restaurant and a spa. Of course, the buyer will have final say. The conversion is estimated to be at least 3-4 years away.
