



INSTRUCTIONS FOR COOL RACING PARTS WRAPS AND PADS

FOR OFF ROAD RACING USE ONLY/USE AT YOUR OWN RISK

ALWAYS INSPECT THE ITEM TO ENSURE THERE ARE NO HOLES OR DAMAGE TO THE PART.

STEP ONE: FOR THE FIRST USE, SHAKE THE WRAP/PAD EVENLY TO DISTRIBUTE THE SUPER-ABSORBENT DRY CRYSTALS THROUGH THE CHANNELS. THEN FILL A CONTAINER LARGE ENOUGH TO HOLD THE PART. ALWAYS USE ROOM-TEMPERATURE WATER. AVOID USING ICE WATER FOR ACTIVATION AS IT SLOWS DOWN THE INFLATION PROCESS. ALSO, AVOID LEAVING WATER IN FOR EXTENDED PERIODS AS IT CAN CAUSE THE PRODUCT TO EXPAND LARGER.

STEP TWO: WHEN THE PRODUCT IS PLACED UNDER ROOM TEMP WATER, IT WILL BEGIN TO INFLATE. MASSAGE THE PART EVERY 5-10 MINUTES, ALLOWING IT TO EXPAND TO ITS PROPER SIZE IN ABOUT 25-35 MINUTES. ALWAYS MONITOR THE ACTIVATION TO AVOID OVERINFLATION

STEP THREE: ONCE THE PRODUCT HAS REACHED THE DESIRED SIZE, REMOVE IT FROM THE WATER AND LET IT DRIP DRY OR WIPE DRY WITH A TOWEL. THIS PRODUCT WILL NOT LEAK OR DRIP WATER.

STEP FOUR: COOL THE ITEM IN AN ICE COOLER, ICE BAG, OR REFRIGERATOR FOR 20-30 MINUTES OR MORE BEFORE USING. YOUR PART IS READY TO BE USED

STEP FIVE: PLACE THE PART ON THE OBJECT TO BE COOLED AND FOR ADDITIONAL COOLING PLACE AN ICE BAG ON TOP OF THE PART FOR 10-30 MINUTES OR LONGER FOR GREATER COOLING AND FOR OPTIMAL COOLING TEMPERATURES

STEP SIX: REMOVE THE PART BEFORE MOVING THE VEHICLE FROM ITS STATIONARY POSITION

DAILY USE: AFTER A FEW USES OR DAYS, THE PRODUCT WILL BEGIN TO DEFLATE. REPEAT STEP NUMBER 2. WHEN NOT IN USE, STORE THE PRODUCT IN A VEGETABLE BIN IN A REFRIGERATOR COLD COOLER BUT OUT OF THE WATER. NOTE THE PRODUCT WILL CONTINUE TO GROW IN SIZE IF LEFT IN WATER OR ON ICE FOR TOO LONG.

CLEANING: WASH IN SOAPY WATER WITH GENTLE BROAD STROKES ON BOTH SIDES THEN RINSE UNDER RUNNING WATER AND HANG OUT TO DRY ON SOMETHING STRONG ENOUGH TO SUPPORT IT.

AFTER MANY DAYS OR A LOT OF USES, THE PRODUCT WILL RETURN TO ITS ORIGINAL STATE. DO NOT FREEZE!!! THIS WILL EVENTUALLY DESTROY THE CRYSTALS THAT ABSORB THE WATER. DO NOT STORE IN A COOLER OR CONTAINER WITHOUT CONTINUOUS COOLING, THE ITEM MAY MOLD. IF YOU GET EXPOSED WITH THE WATER RETAINING CRYSTALS INSIDE JUST WASH YOUR HANDS WITH MILD SOAP AND WATER, IF SWALLOWED CALL POISON CONTROL.
