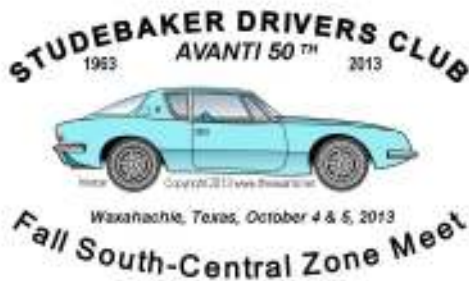

St. Joseph County Parks Foundation has launched a program to restore and preserve the historic tree grove that spells 'Studebaker', located at the old proving ground. This landmark grove of red and white pine will have dead trees replaced, understory cleared and a continuing maintenance program initiated. Private groups can 'adopt' a tree for \$2,000 to augment the funding effort. 2013 is the 75th anniversary of the planting of the trees by the Civilian Conservation Corps in 1938, as a tribute to the growing aviation industry.
