- Ages 5 years to 7 years Contestants must have reached their 5<sup>th</sup> birthday by midnight June 30<sup>th</sup>, 2019 and cannot have reached their 8<sup>th</sup> birthday by midnight June 29<sup>th</sup>, 2019
- Contestants must be the winner or runner up in the local contest in order to compete at the Kentucky State Fair. The contestant winner becomes ineligible to participate in any other Kentucky County Fair Pageant. (Runner-up is accepted should for any reason the winner become ineligible or unable to attend the Kentucky State Fair in Louisville) Both boy and girl must be the winner or runner-up in the contest to compete at the state level. The state fair winner will only make an appearance at the KY State Fair. The local winner will make all of the local appearances for example fair week, Christmas Parade, Diversity Parade etc.
- Contestant interview appearance:
  - Each contestant will have a 5 minute interview
  - The dress code will be dress pants, khaki pants, dress shirt, dress, suit, work casual. NO shorts.
- Contestant Pageant Appearance:
  - o Girls Sunday dress, or slacks. Dresses and skirts should be an appropriate length. .
  - Boys short sleeved shirts with a collar (Izod, Polo, etc.), shorts, khakis, slacks.
  - No formal wear. No pageant dresses, no custom outfits, no tuxedos.

#### The State Winning Couple will be required to attend the following:
