In the coming weeks we will be sending out information about the pageant. Please ensure you provide a working email address, and a working cell phone number.

There will be an informational meeting held prior to the pageant. Everyone will be notified by email, phone or Facebook. There will also be a rehearsal for this division, unless you live out of town and are unable to make it. We have secured a former Miss Kentucky to coach the contestants in onstage question, walking, and interview. We are really excited to have her coming to assist everyone. We also have secured a great professional photographer. He will be doing giveaways, and doing pre-sales on photo packages. He will do onstage shots, head shots and many more. We are working to host an event for the contestants so they can get to know one another better in order to vote for Miss Congeniality.

16 – 21 years of age

Pageant will begin at 6:30 p.m. line up begins at 5:30 p.m. All contestant helpers must leave the dressing area at 5:30 p.m.

There will pageant committee members or volunteers to help anyone that may still need some help.

- Contestants must be single, may have never been married, never had a marriage annulled nor have children.
- Contestants will be judged on the following:
 - *Personality *Interview
 - *Charm *Beauty
 - *Health *Poise
- Any contestant that has competed on a professional level will be ineligible for this pageant (Professional is defined as: Any contestant that has performed or competed for monetary gain in anything other than amateur contest)
- Contestants must be 16 years of age by October 31st, 2019 and cannot have reached their 22th birthday by October 31, 2019 the year the pageant is held.
- There will be the winner chosen as the Kentucky State Fair Winner: Contestants must be the winner or runner up in the local contest in order to compete at the Kentucky State Fair. The winning contestant will become ineligible to participate in any other local contest. (Runner-up is accepted should for any reason the winner becomes ineligible or unable to attend the Kentucky Association of Fairs and Horse Shows). A contestant must represent the first fair that she wins first place in during that calendar year. The winner of this division will only represent Henderson County at the State Fair level. **This category is OPEN to all Kentucky residents**
- The Miss Division will also have a local winner that will represent Henderson in all of the local events such as but not limited to the fair events, Christmas parade, Diversity Parade. The local winner will be a resident of Henderson County.
- Contestant interview appearance:
 - Each contestant will have a 5 minute interview
 - The dress code will be business attire, please pay attention to the length of skirts and dresses.
- **Contestant swimsuit appearance:**
 - Each contestant will show a **one piece swimsuit** on stage (Pageant swimsuit isn't necessary). The swimsuit may be based on personal taste however two-piece, French cut, mono-kini, keyholes or swimsuits with cut outs will not be allowed. High heels are recommended.
- Contestant evening dress appearance:
 - Contestants will be judged in evening gowns
- Contestants may have one (1) female adult assist them while preparing for the pageant- NO EXCEPTIONS
- NO cameras or recording devices are allowed in the dressing area, No MEN in the dressing room.
- Non-Contestants will be required to exit the dressing area at 5:30 p.m. at no time are parents, guardians, or person assisting a contestant allowed in the backstage area.
- Contestant is responsible for their clothing and personal items – Fair or pageant committee will not be held responsible.

The Henderson County State Fair Representative will be expected to attend the following:

- The Kentucky State Fair in Louisville to compete on behalf of Henderson County in (registration for this event will be provided/ date to be announced)

The Henderson County Local representative will be expected to attend the following events, there may be others added. The added events will have some optional attendance but others will be mandatory. We will provide advance notice.

- Henderson County Christmas Parade (1st Saturday in December) Winner can provide their own car to ride in or the pageant committee can help obtain one. Please notify Heather or Jaci by November 1st, 2019 if you need a car. The pageant parade participants will meet at Firedome at 8:00 a.m. for the annual breakfast.
- Henderson County Fair: July 5th and 6th Rodeo, July 12th and 13th, 2019.
- Livestock awards on July 24th, July 25th, and 26th, 2019
- Diversity Parade: Aug 1st, 2019 approx. date.
- Contestant will be invited to participate at other events throughout the year however some of them will be optional and others will be mandatory. I

Winners of the Miss Henderson Pageant will be ineligible to compete in this category in the future.
