There will also be a rehearsal for this division, unless you live out of town and are unable to make it. We have secured a former Miss Kentucky to coach the contestants in onstage question, walking, and interview. We are really excited to have her coming to assist everyone. We also have secured a great professional photographer. He will be doing giveaways, and doing pre-sales on photo packages. He will do onstage shots, head shots and many more. We are working to host an event for the contestants so they can get to know one another better in order to vote for Miss Congeniality.

• Contestants will be judged on the following:

*Health	*Poise

- Any contestant that has competed on a professional level will be ineligible for this pageant (Professional is defined as: Any contestant that has performed or competed for monetary gain in anything other than amateur contest)
- Contestants must have reached their 8th birthday by June 30th, 2019 and cannot have reached their 13th birthday by October 31, 2019 the year the pageant is held.
- Contestants must be the winner or runner up in the local contest in order to compete at the Kentucky State Fair. The contestant winner becomes ineligible to participate in any other Kentucky County Fair Pageant. (Runner-up is accepted should for any reason the winner becomes ineligible or unable to attend the Kentucky Association of Fairs and Horse Shows). A contestant must represent the first fair that she wins first place in during that calendar year. The Pre-Teen Division is OPEN to all Kentucky residents this year. One Local winner will represent Henderson County at all the local events. The State Fair winner will represent Henderson County at the KY State Fair only.
- Contestant interview appearance:
 - Each contestant will have a 5 minute interview
 - The dress code will be business attire, please be mindful of the length of skirt or dress.
- New Category Fun Fashion This is exactly what it states a fun outfit with a sense of fashion and bling. NO Formal Dresses in the Fun Fashion. If you go on google and search for "Pageant Fun Fashion" several examples are available. More information will be available at the informational meeting.
- Contestant evening dress appearance:
 - Contestants should wear a pageant length dress however it must be age appropriate. This age division typically wears floor length dresses.

Example: crop tops, keyholes, strapless, and slits in skirts, are not usually worn in this age group.

- Contestants may have one (1) female adult assist them while preparing for the pageant- NO EXCEPTIONS
- NO cameras or recording devices are allowed in the dressing area. NO MEN in dressing room.
- Non-Contestants will be required to exit the dressing area 30 minutes prior to lineup. There will be a pageant committee member or helper in the dressing room to assist anyone that may need last minute assistance.
- Contestant is responsible for their clothing and personal items Fair and pageant committee and volunteers will not be held responsible.

The State Winner will be expected to attend the following:

- The Kentucky State Fair in Louisville to compete on behalf of Henderson County in (registration for this event will be provided/ date to be announced)
- The Local Winner will be expected to attend the following:
 - Henderson County Christmas Parade 1st Saturday in December.
 - Henderson County Fair events July 5th/6th and July 12th/13th. There will be other events added.
 - Livestock awards: during the week of July 30th thru August 3rd
 - Contestants will be invited to participate at other events throughout the year however, some may be optional and some will be mandatory. We are working on setting up other events for the pageant Queens.

Winners of the Miss Pre-Teen Henderson Pageant will be ineligible to compete in this category in the future.
