*There will be an informational meeting held prior to the pageant. Everyone will be notified by email, phone or Facebook. There will also be a rehearsal for this division, unless you live out of town and are unable to make it. We have secured a former Miss Kentucky to coach the contestants in onstage question, walking, and interview. We are really excited to have her coming to assist everyone. We also have secured a great professional photographer. He will be doing giveaways, and doing pre-sales on photo packages. He will do onstage shots, head shots and many more. We are working to host an event for the contestants so they can get to know one another better in order to vote for Miss Congeniality.*

Pageant begins at 6:30 p.m. line up begins at 5:30 p.m.

- Contestants must be single, may have never been married, never had a marriage annulled nor have children.
- Contestants will be judged on the following:
  - \*Personality
  - \*Interview
  - \*Charm
  - \*Beauty
  - \*Health
  - \*Poise
- Any contestant that has competed on a professional level will be ineligible for this pageant (Professional is defined as: Any contestant that has performed or competed for monetary gain in anything other than amateur contest)
- Contestants must have reached their 13<sup>th</sup> birthday on October 31st, 2019 and cannot be 16 by October 31, 2019 the year the pageant is held.
- Contestants must be the winner or runner up in the local contest in order to compete in the Kentucky State Fair. The contestant winner will become ineligible to participate in any other local contest. (Runner-up is accepted should for any reason the winner becomes ineligible or unable to attend the Kentucky Association of Fairs and Horse Shows). A contestant must represent the first fair that she wins first place in during that calendar year. This year the Teen Division will be open to all Kentucky residents. We will have two winners in this division. The local winner will represent Henderson County in all local events. The State Fair Winner will represent Henderson County at the KY State Fair.
- Contestant interview appearance:
  - Each contestant will have a 5 minute interview
  - The dress code will be business attire. Please be mindful of skirt and dress length.
- Contestant evening dress appearance:
  - Contestant will be judged in formal evening gown
- Contestant Fun Fashion appearance: This category is simply any outfit that is fun and makes a fashion statement. I have seen a lot of girls that wear rompers pant/shorts that are very sparkly and shining with a sheer skirt attached on a belt at the waist. If you google “Pageant Fun Fashion” there are several ideas that will come up. NO FORMAL GOWNS for Fun Fashion category.
- Contestants may have one (1) female adult assist them while preparing for the pageant- NO EXCEPTIONS
- NO cameras or recording devices are allowed in the dressing area, No men will be allowed in dressing area.
- Non-Contestants will be required to exit the dressing area when line up begins; at no time are parents, guardians, or person assisting a contestant allowed in the backstage area. All contestant helpers will be required to leave the dressing area at 5:30 p.m. NO EXCEPTIONS. We will have pageant committee members and volunteers available to help anyone that needs help before going on stage.

The State Winner will be expected to attend the following:

- The Kentucky State Fair in Louisville to compete on behalf of Henderson County in (registration for this event will be provided/ date to be announced)

The Local Winner will be required to attend the following:

- Henderson County Christmas Parade the first Saturday in December. The Diversity Parade is typically around August 1<sup>st</sup>.
- Henderson County Fair – The local winner will be expected to attend the Fair Events on July 5<sup>th</sup>/6<sup>th</sup>, 12<sup>th</sup>/13<sup>th</sup>/14<sup>th</sup>.
- Livestock awards: during the week of July 29<sup>th</sup> thru August 3<sup>rd</sup>
- Contestant will be invited to participate at other events throughout the year some of them will be mandatory while others will be optional. If you are unable to attend an event please notify the pageant administrators as soon as possible.
