To enter the pageant:

- Registration for the pageant must be mailed with all information and payment to either of the following addresses.

- The deadline to enter is August 22nd, 2020. There will be no entries accepted at the door. Copy of the birth certificate also must be submitted with registration or the night before your event.
- Henderson county fair pageants are semi-open. Meaning, open to just the Western Coal Field regions, not all of Kentucky. This region includes Butler, Daviess, Hancock, Henderson, Hopkins, McLean, Muhlenberg, Ohio, Union and Webster County.
- An informational meeting will be held on Monday August 24th at 6pm. This meeting will be held at the Henderson County Fairgrounds; the same location as the pageant. This meeting is by no mean mandatory but highly suggested. If a contestant or representative of the contestant is unable to attend we will be sure to get that information to you as well.
- Queens will be required to attend any fair or community based events held in the future during her reign. We would love our queens to be as involved as possible.

*The Henderson County Fair, its affiliates or volunteers are in no way responsible for any damages, thefts or accidents. In no way are we responsible for any disqualification or scores of the winners/contestants. Grounds for disqualification can be but not limited to: untrue statements on registration forms, unruly behaviors, misconduct, obscene- foul language and any other reasons the pageant committee may deem as necessary.*

The following rules are from the  
Kentucky Association of Fairs and Horse Shows  
*(and under no circumstance can be changed or wavered from)*

The contestant must be a Kentucky state resident.

A contestant can only represent one local fair and must represent the first local fair that they win first place in during the calendar year

The contestant must be a natural-born female, single, never married, never had a marriage annulled, and never had any children.

Every contestant must submit a copy of their birth certificate as proof of age and qualification to compete.

Every Miss contestant must be 16 years of age on October 31, and cannot be 22 on October 31 of the year when the local pageant is held at the local fair.

Every Teen contestant must be 13 years of age on October 31, and cannot be 16 on October 31 of the year when the local pageant is held at the local fair.

Every Preteen contestant must be 8 years of age on June 30, and cannot be 13 on October 31 of the year when the local pageant is held at the local fair.

Winners of KAFHS pageants are expected to attend the other three KAFHS pageant programs in the coming year.

Anyone winning a KAFHS state title is not eligible to compete in that pageant thereafter.

Contestants may not compete in any other pageant system that would prohibit the fulfillment of responsibilities through the state during her reign as Miss Kentucky County Fair

Last but not least, the following document is the code of conduct. This code of conduct must be signed by all Pre- Teen, Teen, and Miss contestants as well as their parent/guardian. This set of rules is to be obtained by all of our Miss Henderson County queens.

As a representative of Henderson County said contestant agrees to the following guidelines for conduct during her reign.

The contest must be a resident from one of the following counties: Butler, Daviess, Hancock, Henderson, Hopkins, McLean, Muhlenberg, Ohio, Union or Webster.

Contests must be born a female and must have never been married, had a marriage annulled or have children. If a contestant becomes pregnant during their time representing Henderson County Fair, your title will automatically be stripped and you must return all awards presented.

Every Miss contestant must be 16 years of age on October 31st, and cannot be 22 on October 31st. Every Teen contestant must be 13 years of age on October 31, and cannot be 16 on October 31st. Every Preteen contestant must be 8 years of age on June 30, and cannot be 13 on October 31st.

Each (qualifying) queen will compete in their age division at the State level in Louisville Kentucky.

Each queen will be required to attend any fair related event as well as community based events held in the future during their reign.

I will not behave in a manner that is disrespectful to myself or in a manner that is not morally and ethically respectful to the county and the title I hold.

I will not participate in any harmful, malicious, defaming or slanderous speech towards Henderson County, fair staff members, sponsors or contestants.

Whether this is oral or written during my reign as well as after the local pageant.

I will not consume and/or use alcohol and/or illegal drugs while participating in any function or event from the beginning of my reign until the end.

I will acknowledge that ALL of my social media content, as well as any other internet website, is considered a reflection of myself as a titleholder and the Henderson County Fair.

Any suggestive photos or verbally explicit comments must be removed during my local reign. I will agree to comply with any request made by the Henderson County Fair Board and my directors.

If at any time a Henderson County queen breaks this agreement, actions may be brought before the Henderson County Fair Board for consideration of removal of her title. In the case that her title is removed, duties will be relinquished to the first runner up.

By submitting this form, I confirm that I have read and understood the pageant agreement and code of conduct. I understand that failure to these terms may result in dismissal and disqualification as a contestant or titleholder.
