



Health Guarantee & Sales Contract

The kitten is healthy and current on all vaccinations. All follow-up Vaccinations and any or all other veterinary health care are the responsibility of the buyer. This cat/kitten is guaranteed to come from a Feline Leukemia/Feline Aids negative, PKD negative household. This cat/kitten is guaranteed for six months against Feline Leukemia/Feline Aids. If that is proven by a veterinarian, the seller will give the buyer another cat or kitten as a replacement. Refunds are not given. Buyer is responsible for any medical expenses incurred including necropsy and shipping costs of replacement.

The seller will not be held responsible for the stress and diseases from it that kitten can be possibly exposed to during shipping transport. Buyer should be aware that during times of stress, shipping, go to new home, living new environment, meeting new people and new animals, cats can exhibit a variety of symptoms, such as sneezing, watery eyes, runny nose, lack of appetite, constipation, or diarrhea. This is completely normal and usually of short duration.

cats are naturally at risk for viral and bacterial colds, and worms, which is often brought on by the stress of a new home, new food, new people, or just a change in environment.

Buyer assumes all responsibility for vet costs accrued after the time the kitten has left the breeder's home. The kitten must be examined by a licensed veterinarian within 72 hours of the pickup or delivery time. In the event that the buyer fails to have the mandatory exam completed within 72 hours of pickup or delivery, this contract will be rendered null and void.

Kitten is provided with 30 days of trial insurance. The buyer must activate this insurance within 24 hours of the kitten going home. Failure to activate the insurance will render this contract null and void.

The breeder agrees that the kitten/cat is in good health at the time of sale, and that any identified health problems are known to the purchaser in writing prior to purchase.

Our kittens are spayed or neutered prior to leaving to new home. If not, buyer is responsible for costs of spaying and neutering. A neuter/spay certificate is required from a veterinarian to be sent by the buyer to the seller by the time the cat/kitten is 6 months old. This cat **CAN NOT** be used for BREEDING Purposes.

Seller have the right to refuse the adoption at any given time during the adoption process. Any and all deposits or adoption fees will be returned in full.

“A Breach of Contract” and shall make this contract null and void. This contract applies only to the original purchaser and is NOT transferable.

Breach of contract penalty is \$1,000.00 per item. It is mutually understood that failure to comply with any provision of this contract may detrimentally affect the reputation and business of Peachy Me Cattery. Any litigation arising from disagreements between seller and buyer must be filled in the county and state of the seller. Buyer will be liable for any court costs and related charges associated with the seller enforcing the terms of this contract. Seller retains a security interest in this cat/kitten for purposes of enforcement of this contract, and may enforce that action without judicial intervention.

Please verify that buyer are NOT allergic to cats before inquiring because refunds will not be given due to allergies.
