- 1. Call to Order John Rice @ 7:03 p.m. EST
- 2. Roll Call of board members and residents

- 3. Approval of October Meeting Minutes (please read prior to meeting)
 - a. Motion to approve minutes carried
 - i. 1st: Mike Smith
 - ii. 2nd: Mellanie "MJ" Hunter
- 4. AT & T Fiber Discussion Paul Coffman, Outside Plant Design Engineer and Hawthorn Glen Resident
 - a. Free internet at Clubhouse
 - b. Provide fiber throughout neighborhood without cost to HOA with signed agreement
 - c. Hawthorn Glen just completed this in their neighborhood. Sixty homeowners out of 300 plus have signed agreements
 - d. Agreement offers residents another option. Newest sections of WOII already has it. Door fee is from \$20-100/lot. Depends on finances of neighborhood. Other AT & T Teams handle this and were not present to handle specifics on this question about door fee.
 - e. What is the new section considered? Pleasant Run, Whispering Way, and Dale cul de sac
 - f. What ownership does AT & T for damage to homeowner lawns as a result of install? There is a project manager through Connected Communities, who would be the point of contact during construction.
 - g. How was construction in Hawthorn Glen? When placement was complete, AT & T knocked on every door to address restoration concerns. Most concerns are from directional boring and manual stich boring around about a 30 X 30 space within public utility easement and road right of way.
 - h. Data rate? Up to 1G initially. 2 and 5 gig services can be obtained.
 - i. Pricing? Subject to change. As of now, \$55/month for 50mb and \$80 for 1G and so on. Owners are able to pay for two circuits vs. one, if desired.
 - j. Money comes to Board upon completion of project. Completion takes around 6-7 months.
 - k. Hawthorn Glen had an open ballet vote in order to gauge interest.
 - l. Danbury Oaks Board made the decision vs. doing a vote.
 - m. What would next steps be? Board needs to respond to email showing our interest and they would gather financials. This would help us learn door fees and inform best next steps to engage the community. End goal would be every address in WOII has the option to connect to AT & T fiber, if we move forward.
