 - a. Lot Purchase update.

 - iii. Cost: \$200.00 (non-refundable) money would go towards expansion project.
 - iv. Concerns: Managing areas after party
 - v. Residents can still come, regardless if the clubhouse and pool is reserved.
 - vi. NO reservations of clubhouse or clubhouse and pool on Holidays.
 - b. Motion carried to do a trial period of residents booking the pool with their clubhouse reservation for the 2024 pool season.

 - 3 Increase fees for all 10 to \$500.00
 - d. Motion carried to open it up to 10 WO I households and increase dues to \$500.00 for each household. WO I residents would be required to sign our Clubhouse Waiver annually. This would be a trial period for one year starting June 2024-May 2025.
