- 1. No new field requests/issues for Rick at this time, just need to confirm if there were any conflicts known for our previous field request, specifically with Wasserman and Parks and Rec, as they tend to hold events in the spring/summer we need to be mindful of when scheduling.
- 2. 234 registered players for spring season so far (279 in SP 2023). Registration will remain open until the end of the month, and we're hoping to start once the fields are released in mid-April.
