- Lacrosse – Craig's wife attended meeting, Homecoming May 17th. 140 registered, a month away from close. New board members onboarded. Transfer station fundraiser scheduled. Dome payments imminent. Open house/free client Feb 1 with the high school coaches and players. 35-40 registered.
- Softball – Registration open. 5 travel teams, winter trainings underway. Gym requests in, waiting on John's response. Request to use sign at building. Code of conduct added to registration.
- Baseball –
 - Spring registration is open with 76 players and 17 volunteers registered thus far. Flyers will be going out through the school shortly, and registration will close on 2/28.
 - The board decided to provide a \$10 "early registration" discount for anyone who registers on or before 1/31, after that, regular registration fees will apply.
 - The board is looking to formalize an agreement with the Nashua Baseball Umpires Association for 2026, as we have largely operated with an informal agreement on both sides.
 - The board is awaiting confirmation of 2026 insurance policy, but the charter has been submitted and Holly Golden was to process payment directly.
 - Prior to the start of the spring season, the board is planning to offer a winter clinic with the Merrimack Valley Prospects travel program using their space in Nashua, NH, and will also plan to hold at least one "Coaches clinic" using the Nashua Umpires Association.
 - All gym requests have been submitted and no new field needs at this time.
 - Getinge is waiting for the Merrimack Fire Department to move forward with their plans. The last updated said this process is underway but no timeline has been given.
- Golf – Registration opens January 26th – program will run the same as last year, 20 kids K-4th and 20 kids 5th-8th. We expect a large waitlist due to the amount of people who have emailed to get on the mailing list.
- Soccer – Registration opened today for rec. Travel tryouts are in Feb for Spring. Travel season will open 4/11. Gym requests are in and will get in after basketball. Would like to speak to Budweiser about fields. Discussion with Lacrosse about field use. Board is full!
- Football/Cheer – Five new board members, other than concessions manager, full board. New helmets to be purchased this year.
