• Warrant Article for Pearson Rd Field - Nancy Harrington update: Town Council is in favor of MYA bringing forth a Warrant Article. Paul MiCali gave us the verbiage for the article. Will need 25 registered voters signatures in order to get it on the ballet. We need to decide whether we want to go for a 1 year tax funding or a 5 year tax bond. 1 year choice needs submitted to Paul Micali by February 13<sup>th</sup>, would need 51% of the vote, and would be a one time \$0.22/\$1000 valuation tax. 5 year bond choice needs submitted to Paul Micali by February 9<sup>th</sup>, would need 60% of the vote, and would be \$0.05/\$1000 valuation tax for 5 years.

  - O Baseball Regrade Bise to control water. Awaiting response from the town on shed locks from traditional locks to electronic keypad.
