Registration Updates – will be happening in mid-January to early February. Looking to expand the program to two K-4 groups, Monday/Tuesday, enrollment from 20 kids to 32 kids (pending we get more coaches). 5th-8th group will remain as one but expand from 20 to 24 kids.
