The Youth and College Assistance Programs are open. Please contact us on more information on eligibility and the application process.



PLANNING AND DEVELOPOMENT CONT'

On February 3, 4, and 5 the Commissioners and Staff worked with See Renewal Consultant, Amy Wilson and staff, on a Community Needs Assessment, Strategic Housing, Land Acquisition & Land Use Project for the Housing Authority. The plan will set goals to overcome housing deficiencies, gaps in community services, and economic challenges, and it will build a framework for achieving those goals. The Work Plan will be used to justify and secure funding needed to advance the Housing Authority's goals and objectives while the Housing Plan is being developed.

We will keep everyone updated through our newsletter and other correspondence, such as Community Meetings, Surveys, press releases, etc., so that everyone knows how this plan will benefit our Community, Tribal members, and future tenants of the Housing Authority.

RURAL ENERGY PILOT PROGRAM

The Pawnee Nation Rural Energy Pilot Program (REPP) has been busy signing up "Energy Champions" for the sensor program, working on community engagement, and installation of the sensors and thermostats. The program has been very busy these last few months as we are continuing with phase 2 of the project and moving into phase 3.

REPP had a workshop on February 20th at 5:30 PM at the Pawnee Nation Housing Authority Conference Room. We apologize for the technical difficulties for the virtual component, there were issues with the Teams App that evening.

The event was attended by local community members. Participants were able to see how the sensors work and get more of a technical idea by the Company Emporia, on how to read the data.

Each participant was able to take home REPP promotional items from pens, bags, tumblers and t-shirts. We wanted to thank everyone who has signed up for this program.

MAINTENANCE ACTIVITIES

The maintenance staff have been cutting trees and removing debris on the 14 acres south of town. They have also been mulching the limbs for future use.

The crew had been working on three (3) non-NASHASDA homes located at 403 Forest Street, 704 Forest Street and 419 Park Lane. Two (2) of the units are now occupied and we are seeking applicants for the last one on 419 Park Lane. This is a unit that is open to anyone who is over the income guidelines of the 80% median.


Continued work on a few rehabs at Littlesun Addition are on going. The staff are still working on Unit 113 with plans to start soon on Unit 116. These units will be getting a face lift and new appliances to get ready for new tenants to move-in. The unit at 106 Eagle Chief is now ready for occupancy for applicants.

The Commissioners are continuing to work on the Non-NAHASDA Lease Purchase Program and then we will seek applicants for 307 Ash Street.

HOUSING AUTHORITY NEWS

AVAILABLE HOUSING

Housing Authority is The seeking tenants for 106 Eagle Chief Drive. This home is a three (3) bedroom home with 1 full bathroom, garage and nice living space. Eligibility requires the applicant the HUD income within guidelines, under the 80% median. be a Pawnee Tribal member or other federally recognized tribe, and submit documents for a background check. Monthly rent is income based, no higher than \$391 plus a \$300 security deposit. All of our applications are online at our website or can be picked up at the Housing Office.





The Housing Authority is seeking tenants for 219 Park Lane. This home is a trailer home with three (3) bedrooms, 2 full bathrooms, car port, and utility shed. This home is income based and to qualify you must be over the income guidelines of the 80% medium. Any community member may qualify for occupancy. The monthly rent for this unit is \$800 with a \$300 security deposit. Renter is responsible for all utilities and lawn upkeep. PNHA COOKING CORNER

SHEET CAKE

Prep Time: 15 mins * Cook Time: 20 mins

Ingredients FOR THE CAKE: 2 cups flour 2 cups sugar

2 cups sugar 1/4 tsp salt 4 tbsp cocoa

16 tbsp unsalted butter

1 cup boiling water 1/2 cup buttermilk

2 eggs

1 tsp baking soda

1 tsp vanilla extract



FOR THE ICING:

14 tbsp unsalted butter

4 tbsp cocoa

6 tbsp milk

I tsp vanilla extract

3 1/2 cups powered sugar

Add to saucepan: water, butter, and cocoa powder and bring mixture to a boil.

<u>In a bowl</u>: mix together the flour, sugar, baking soda, and salt.

In another bowl: mix together the buttermilk, eggs and vanilla. Add mixture to the flour mixture and mix until combined.

Combine the batter. Once the chocolate mixture in the saucepan in boiling, remove it from heat and pour it into the batter. Mix until combined and no lumps remain.

<u>Pour into sheet pan</u>. Pour mixture into prepared pan and smooth with a spatula to make sure it is dispersed in an even layer.

Bake. at 350°F for 15-20 minutes or until set.

In a saucepan: Add milk, cocoa, vanilla, and butter; bring mixture to a boil.

<u>Stir in</u>: powdered sugar. Beat the mixture with hand-held mixer to get rid of any lumps.

<u>Pour over cake</u>. Pour the hot mixture right over the hot cake. Use a spatula to spread it evenly over the cake. Allow frosting to set for about 10 minutes before eating.



EASY CHICKEN TOSTADAS RECIPE

Ingredients
8 corn tortillas (6 inch)
1 tablespoon vegetable oil
8.5 ounces corn, drained
1 1/2 cups shredded cooked chicken
8 ounces salsa
2 tablespoons taco seasoning
15 ounces black beans, drained and rinsed
2 cups Colby Jack cheese, shredded
Fresh cilantro, for garnish
Tomatoes, diced, for garnish

Directions - Preheat your oven to 400°F (200°C). Lightly brush both sides of the corn tortillas with vegetable oil and place them on a baking sheet. Bake for 8-10 minutes, flipping halfway through, until they are crispy.

In a skillet over medium heat, combine the shredded chicken, salsa, and taco seasoning. Stir and cook until heated through, about 5 minutes.

Spread the drained black beans and corn evenly over the baked to stada shells.

Top with the seasoned chicken mixture and sprinkle shredded Colby Jack cheese over each tostada. Return to the oven and bake for an additional 5-7 minutes, or until the cheese is melted. Garnish with fresh cilantro and diced tomatoes

before serving.




