

# RURAL ENERGY PILOT PROGRAM (REPP)

The Pawnee Nation was awarded 2.6 million dollars to promote renewal energy, geothermal and to implement a sensor placement study throughout our community.

The Pawnee Nation Housing is a stakeholder or partner with the Nation along with the Pawnee Nation College, Indian Electric Cooperative, University of Oklahoma and Tribuquent.

Project goals include Community scale solar garden, geothermal project, battery storage system, electric charge stations, educational meetings and workshops, renewable energy certification, institutional partnerships, weatherization planning and cooperative business modeling.

There will be six (6) phases in this project. Currently we are on phase one. Phase one (1) will be for project management, stakeholder and resource planning. The goals will include stakeholder engagement for advisory groups and task force, resource planning to include partner commitment, DER and Sensor placement study to collect data points, and environmental review.

We will report as we progress through the phases of the project.

#### **BOARD NEWS**

At the October 10th Board of Commissioners meeting, the Board was addressed by Ms. Stephanie Townsend to talk about the VOC Rehab program through the State of Oklahoma, also hearing reports from staff on daily operations. The Board did vote on changes made to the PNHA Policies and Procedures Manual, Education Leave Policy for staff who want to further their education, to authorize four (4) hours of education leave a week.

Financial matters were voted on by the board and updates were given on the property sale and purchases.

Mr. Hawkins is a Veteran of the U.S. Navy and has been working for the Pawnee Nation TERO (Tribal Employment Rights Office) Department for the past two and half years. He has also worked with the Pawnee Nation CHR Program.

Some of the initiatives Mr. Hawkins has brought to the table include the implementation and creation of a weapon free policy for Housing to align with HUD guidelines. The Commissioners voted to add this policy as a part of the PNHA Drug Free, Smoke Free, and Weapon Free Policy.

Mr. Hawkins says, " I have enjoyed learning about policy, compliance with HUD guidelines and working with our Pawnee Nation laws. It has been a great experience and honor to watch the other Commissioners learn and grow along with me when making decisions." He also

# EMPLOYEE SPOTLIGHT

The Employee Spotlight is our Executive Director, Mrs. Linda Jestes.

Mrs. Jestes is from the Chapman family and grew up in Pawnee and lived has in the community most of her life. She remembers stories of living on the farm with her brothers and running around the campus. She also was one of the youngest



Pawnee children to live at the Pawnee Boarding School before it closed its doors to students.

Linda lives in Pawnee with her husband, Ronnie Jestes and it is where they have raised their family. She enjoys spending time with her grandkids and great-grand children by watching them play sports and do other activities.

Mrs. Jestes has worked for the Pawnee Nation Housing Authority in many capacities for over 40 years starting back in 1978. She worked as a clerk answering phones and doing basic administrative work for three years. When she wasn't employed with the Housing Authority she served as a Commissioner on the Housing Board. In 2003 to current, she has served as the Executive Director, In addition, she served a term on the Pawnee Business Council as Secretary.

"I have been with Housing for years and I love doing the work. I enjoy helping people and I have been able to do that working here over the years," says Mrs. Jestes.

Although Mrs. Jestes has enjoyed her time at Housing, she did mention she looks forward to retirement in the future. Her work in Housing has been recognized Nationally and our tribe is lucky to have had her serve our people in this capacity. Thank you for your service to the Pawnee people Mrs. Linda Jestes.

# HOUSING FACILITIES

The PNHA has several housing options for the Pawnee tribal community. In total, we have 54 homes in the Pawnee area for families. We have housing based on income that align with HUD income guidelines, our elders complexes and lease to own homes for residents who want to become homeowners. All of our Housing homes are Drug Free, Smoke Free and Weapon Free. To fill out an application to become a PN Housing Authority resident, you may visit our website to download an application or come by the Housing office.

#### NAHASDA HOMES

Our NAHASDA (Native American Housing and Self-Determination Act) homes are based on income in compliance with HUD guidelines. The Housing Authority has thirty-two homes, including the Elders duplexes. Some units range from one (1) to three (3) bedroom homes. Other qualification are required, including a background check for all tenants over 18 years of age in the home. Pawnee tribal members get priority, including disabled and veterans. Those who put in applications are put on a waitlist for the next available unit. Applicants are asked to update their application yearly to remain on the waitlist. Once a unit is available the next person on the list will be contacted. Applicants who are placed in a unit are required to pay a deposit before moving in.

# ELDERS COMPLEXES

Our elder homes are handicap accessible, they feature built in safe rooms, energy efficient appliances, and are equipped with backup generators for power outages. Pawnee tribal members are priority, then other tribes, Veterans, and disabled.

# COMMERCIAL LEASE

The Housing Authority has leased the Pawnee Community Center to the Pawnee Nation TERO Department and is located in downtown Pawnee at 551 Harrison Street. TERO is using the building for office space and training. The building is available for rental with the TERO Department and the application for rental is on the Housings website.

# Non-NAHASDA HOMES

The non-NAHASDA homes are scattered throughout the Pawnee community. These homes are based on HUD income guidelines for families who do not meet the eligibility for NAHASDA units. At this time, the PNHA has a total of 16 non -NAHASDA homes that are occupied. They range from two (2) to three (3) bedroom homes. Eligibility is required, including a background check for all tenants in the home over the age of 18 and meet other eligibility requirements. Applicants are asked to update their application yearly to remain on the waitlist for the next available unit/ The application, along with all of our home. applications, are posted on the Pawnee Nation Housing Authority website. Applicants may also pick up an application at the Housing office.

## HOMEOWNERSHIP

The Housing does have lease own properties or homeownership properties. Currently there are three (3) properties that are currently occupied for this program. Lease to own is based on the income guidelines through HUD and available when applicants are determined to be eligible and a home is available.

## SMOKE & CARBON MONOXIDE DETECTOR PROGRAM

The Pawnee Nation has announced a new program by the Pawnee Nation Fire and Rescue Department that will provide free smoke and carbon monoxide detectors for home safety. This program will provide fire safety awareness to households and assist with creating a fire and safety checklist and plan.

There is a simple application process and an inspection of the home that will be conducted to qualify for installation. 	Cooking Safety				
-	*Keep an eye on what you fry. Stay in the kitchen when frying, grilling or using an open flame.

	*3 feet from the heat.* Furniture, curtains, dish towels and anything that could catch fire are at least 3 feet from any type of heat source.				
9	Smoking Safety				
	Never amoke in bed.

	Make sure you have working smoke alerna. Different types of smoke alerna, ionization and photoelectric, detect fire in different ways. Experts recommend having both types in your home.

#### Types of Fires

**Class A** (plastic, paper, wood, and fabric) extinguish with water

**Class B** (alcohol, oils, solvents, kerosene) extinguish by cutting power, use fire extinguisher **Class C** (electrical components) extinguish by cutting power, use fire extinguisher

**Class K** (cooking fires) extinguish by covering with lid, throwing baking soda or salt on it, smother with wet towel, use fire extinguisher

#### Tips for creating your home fire escape plan and practicing your 2-minute drill:

- Everyone in your household should know *two* ways to escape from each room in your home.
- Smoke is dangerous. Get low and go!
- Decide where to meet once you get outside:
- Get out and stay out. Never go back inside for people, pets or things.
- If a fire starts, you may have less than two minutes to get to safety. So time your fire drills and find out: what's your escape time?
