## RURAL ENERGY PILOT PROGRAM (REPP)

The REPP Energy Coordinator has been out of the office for an internship until September. But the Program has still been busy in phase II of the project continuing with work on community engagement and signing individuals up for the sensor and smart thermostats.

We are still taking applications for smart sensors and smart thermostats. The goal of these sensors is to help people understand their energy usage and control their energy consumption better. This will also help with future weatherization efforts.

As Phase III is soon approaching we are getting ready for the installation of the sensors and thermostats. We are starting with the first 10 homes soon. We are very excited! All of the sensors will be professionally installed, and you will be able to see your real time energy consumption. We will be contacting those who are signed up via email or phone call to let you know about installation of equipment.

## BOARD MEETINGS

---

The Board of Commissioners met on May 14, 2024 with a quorum present. The Board heard two presentations, one from Ms. Amy Wilson on services for planning and development for the 14-acres that was purchased and the other presentation from Mr. Brian Kirk on the Tribal Housing Rebate Program. The Board also continued with discussion on the 2025 Indian Housing Plan on new objectives and goals for the upcoming funding year. In Executive Session there was discussion only on a property purchase, downpayment assistance and the termination of the 551 Harrison Street commercial lease.

The Board of Commissioners met on June 11, 2024 with a quorum present. There was continued discussion on the 2025 Indian Housing Plan. There was an extension on date of submission, which is now July 18th. The Downpayment Assistance Program was closed for the fiscal year and the

assistance was awarded to a Pawnee applicant in the amount of \$10,000. The staff reported to the Board on updates and revisions to the Lease Agreement for tenants and the Board approved a property purchase in Pawnee with non-NAHASDA funds.

The Board of Commissioners met on July 9, 2024 with a quorum present. The Board approved the 2025 Indian Housing Plan.

## COMMISSIONER SPOTLIGHT

---

Our Commissioner spotlight for this edition is Commissioner Seat #4, Ms. Carol L. Nuttle. She has served on the PNHA Board of Commissioners for four years and is on her second term.

Ms. Nuttle is the daughter of the late Frank and Pearl Osborne Nuttle. She is the maternal granddaughter of Sam (son of Billy Osborne, Pawnee Scout) and Effie Little Eagle Osborne. Maternal great grandparents are Mattie Little Eagle and Little Eagle. She is the paternal granddaughter of Ernest and Mary Leader Nuttle. Her paternal great grandparents were Frank Leader and Skatoos. Her aunties/atira are Ramona Little Eagle Osborne and Mattie (Osborne) Fish and her daughter Ms. Mary Angela Thompson (Steh-Ke-Tah-We-Kah-Lah).

Ms. Nuttle is the President of Leader, LLC, owned by her and her daughter. Serving tribes across the country with specialty experience in Self-Governance. They conduct planning and negotiate Federal Compacts and funding agreements on a government-to-government basis to assure the tribal interests are maintained. Other areas of expertise: successful grant writing for development of long-range strategic planning and strategic budgeting, small ambulatory clinics, management of SG administrative and management systems, Community Health Aid Program (CHAP) implementation in the lower 48 states, and more. She is retired from IHS, Headquarters, Office of Tribal Self-Governance, former elected member of the Pawnee Business Council, former Self-

Governance Director for the Kaw Nation and was Regional Director for Council of Resource Tribes (CERT) National Survey of American Indians of Alaska Natives.

Her goal as a Commissioner is to utilize her experience and knowledge of planning and development, and knowledge of administrative structures to make our service accessible to all community members through clear and open communication to the public. Work with the Board of Commissioners through the Executive Director to assure we have policies and a clearly stated application process and procedures to accept, approve and track all applications for the services we provide. She also wants to work on identifying the needs of the community from the community members themselves through surveys, community meetings and other input and prioritize programs to meet these direct needs.

Ms. Nuttle says, "I have enjoyed working with Director, Linda Jestes and all housing staff and serving with the dedicated Commissioners of the Housing Authority. It is my hope that as a Board we can focus on implementing projects that meet the direct needs of the community as identified by the community itself."

Thank you for serving on the Board of Commissioners Ms. Nuttle and good luck with your goals and your second term.



# COMMISSIONER NEWS

Below is the approved goals for the 2025 Indian Housing Plan for the Pawnee Nation Housing Authority. This budget includes the programs that are offered by the Housing Authority. Our fiscal year is from October to September. The table below will show the new FY2025 budget with the comparison of the FY2024 budget.

We did get an increase of funds for FY2025 and look to do more activities for the youth and in crime prevention and safety. The down payment assistance program will be increased so that we are able to serve more first time home buyers. The Development line item is for planning and development services for the 14-acre housing project.

With new funding comes new edibility requirements and guidelines. All of our applications for our modernization and assistance programs will be updated and can be found on our website. ## PROJECT MANAGER UPDATE

---

Greetings from the PNHA Project Manager, George Gardipe. I have been working on a few projects. Our main goal, besides programming, is to provide new rentals and home ownership opportunities for tribal members. We have been actively seeking homes in the community to purchase, for the right price and condition. The 14-acre tract we have previously mentioned is one of the developments we are setting our sights on. Depending on how we proceed, we are determined to get this project off the ground. Currently, the going rate to build a family unit in Oklahoma is over \$300,000, which is a significant amount to build. We are looking at different options for this area. Our board of commissioners is currently seeking a grant writer to help in our development. In our new IHBG (Indian Housing Block Grant) we have committed funds to help in our development.

Recently, our REPP Energy Coordinator (Alex) has been out of pocket on an internship and I have been filling in to devote time to community events to disseminate information for our public. We are still needing volunteers to sign up. We will be collecting data for the next couple of years to determine where your consumption is being utilized, along with the time of day, etc. We will also employ smart thermostats that will be connected. The only requirement is that you currently have internet access so that the energy sensors will be able to communicate and share data. This will cost you nothing, just a better understanding of how your electricity is being distributed. We hope to use this data to improve participants' homes with future offers of efficiency.

## MAINTENANCE ACTIVITIES

---

The maintenance staff have been busy getting housing ready for new tenants. Currently our staff are working on home renovations at four of our properties.

We have recently purchased a non-NAHASDA Lease Purchase Home at 307 Ash. This home is being fully renovated and we will get pictures of the progress as we move forward.

There are two (2) non-NASHASDA homes that are also being cleaned and rehabbed at 122 Yellowhorse Drive and at 219 Park Lane.

We are almost completed with a few more rehabs here at Littlesun Addition. Our staff have been working diligently on completing 108 Eagle Chief and will soon start working on Units 106, 113 and 116.

## APPLICATION & WAIT LIST PROCESS

What happens after you turn in an application? Here are the steps the Housing Office uses to process applications.

1. A written application by a responsible member of the family will be obtained from each family seeking admission with all supporting documentation and identification attached.
  2. Processing: Verified information will be analyzed and a determination made with respect for the following:
    - a. Verification of applicant as a family - Background checks, Landlord check
    - b. Eligibility of applicant with respect to income limits for admission - Income verification with employer
    - c. Size of unit required for the family
    - d. Preference and/or Priority of applicant family - Priority #1 - Pawnee Tribal Members, Priority #2 - Pawnee Descendancy, Priority #3 - Other federally recognized tribes. Preference - Veterans, Elders and disabled
    - e. Determination of eligibility with respect to standard of admission of Housing programs.
  4. After all verification is cleared, the application is forwarded to the waiting list based on preference, priority, family size and income.
  5. Applicants should update their application annually to remain on the waiting list.
  6. Once a unit becomes available the next applicant on the waiting list will be contacted.
- A deposit of \$300 and first months rent is due before the applicant moves in.

### Types of Fires

**Class A** (plastic, paper, wood, and fabric) extinguish with water

**Class B** (alcohol, oils, solvents, kerosene) extinguish by cutting power, use fire extinguisher

**Class C** (electrical components) extinguish by cutting power, use fire extinguisher

#### Tips for creating your home fire escape plan and practicing your 2-minute drill:

- Everyone in your household should know *two* ways to escape from each room in your home.
  - Smoke is dangerous. Get low and go!
  - Decide where to meet once you get outside:
- 
- Get out and stay out. Never go back inside for people, pets or things.
  - If a fire starts, you may have less than **two minutes** to get to safety. So time your fire drills and find out: what's your escape time?
