AT DANCE WITH GRACE, WE STRIVE TO CREATE A POSITIVE, RESPECTFUL, AND PROFESSIONAL ENVIRONMENT FOR ALL STUDENTS, PARENTS, AND STAFF. PLEASE REVIEW THE FOLLOWING IMPORTANT POLICIES:

1. BUSINESS HOURS

- OUR BUSINESS HOURS ARE 9:00 AM – 6:00 PM, MONDAY TO FRIDAY.*
- PLEASE ENSURE ALL COMMUNICATION, INCLUDING PHONE CALLS, MESSAGES, AND EMAILS, IS MADE DURING THESE HOURS.*

2. PRIVATE LESSONS

- ALL PRIVATE LESSONS MUST BE PAID FOR UNLESS CANCELLED BY THE TEACHER.*

3. CLASS FEES

- FEES ARE PAID BY THE TERM AND MUST BE FINALISED BY WEEK 2 OF EACH TERM.*
- PAYMENTS CAN BE MADE IN FULL OR IN TWO INSTALMENTS IF ARRANGED IN ADVANCE.*
- A 10% LATE FEE WILL APPLY TO FEES NOT PAID ON TIME.*

4. DRESS CODE

- BALLET STUDENTS MUST WEAR THE CORRECT UNIFORM AND HAVE THEIR HAIR IN A NEAT BALLET BUN FOR EVERY CLASS.*
- STUDENTS IN ALL OTHER STYLES MUST WEAR THE CORRECT UNIFORM FOR THEIR CLASS.*
- HIP HOP IS THE ONLY STYLE WITH FLEXIBILITY IN UNIFORM REQUIREMENTS.*

5. STUDIO ETIQUETTE

- PARENTS ARE NOT PERMITTED IN THE STUDIO DURING CLASSES, EXCEPT FOR BABY BALLET CLASSES.*
- THIS POLICY ALLOWS STUDENTS TO REMAIN FOCUSED AND PROMOTES INDEPENDENCE.*

6. CHOREOGRAPHY USE

- IF A STUDENT CHOOSES TO LEAVE DANCE WITH GRACE AND JOIN ANOTHER STUDIO, THEY ARE NOT PERMITTED TO PERFORM ANY SOLO ROUTINES LEARNED AT DANCE WITH GRACE. THIS POLICY PROTECTS THE INTEGRITY OF OUR CHOREOGRAPHY AND THE HARD WORK OF OUR TEACHERS.*
