EXPORT COMPLIANCE CERTIFICATION

I (We) acknowledge U.S. Law prohibits sale, transfer, export or re-export or other participation in any export transaction involving our products with individuals or companies listed in the U.S. Treasury Department, Office of Foreign Assets Control (OFAC), lists of Specially Designated Nationals and Blocked Persons (SDNs) and Specially Designated Terrorists (SDTs), the U.S. Commerce Department, Bureau of Industry and Security (BIS), Denied Persons List or Entity List; or the U.S. Department of State's lists of Foreign Terrorist Organizations, Specially Designated Global Terrorists, or individuals debarred from receiving Munitions List items;
4. I (We) will abide by all applicable U.S. export laws and regulations for any product purchased from Aerospace Global Industry Supplies LLC (DBA Winged Tycoons) and will obtain any licenses or prior approvals required by the U.S. Government prior to export or re-export of Winged Tycoons' items.
