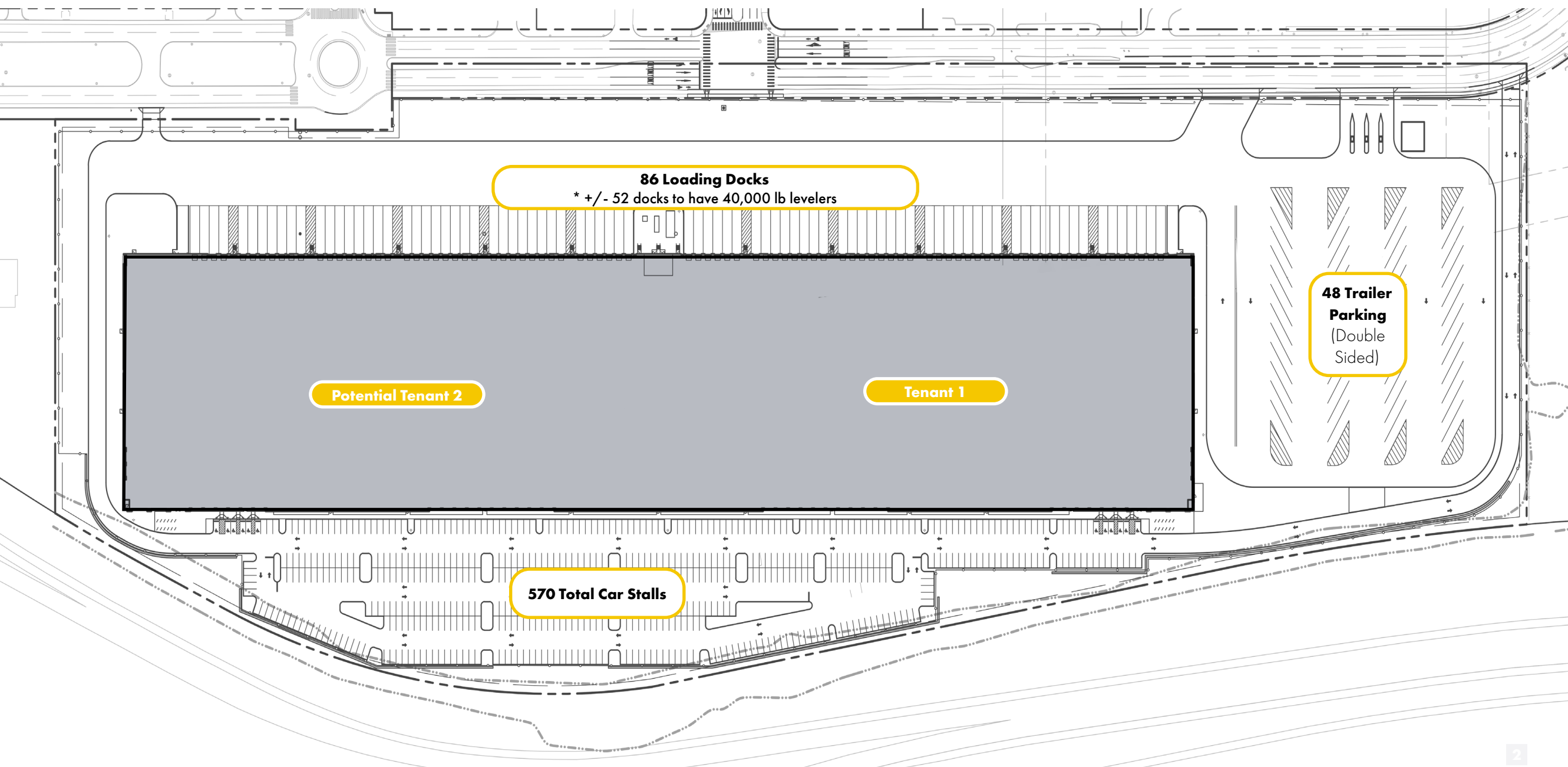

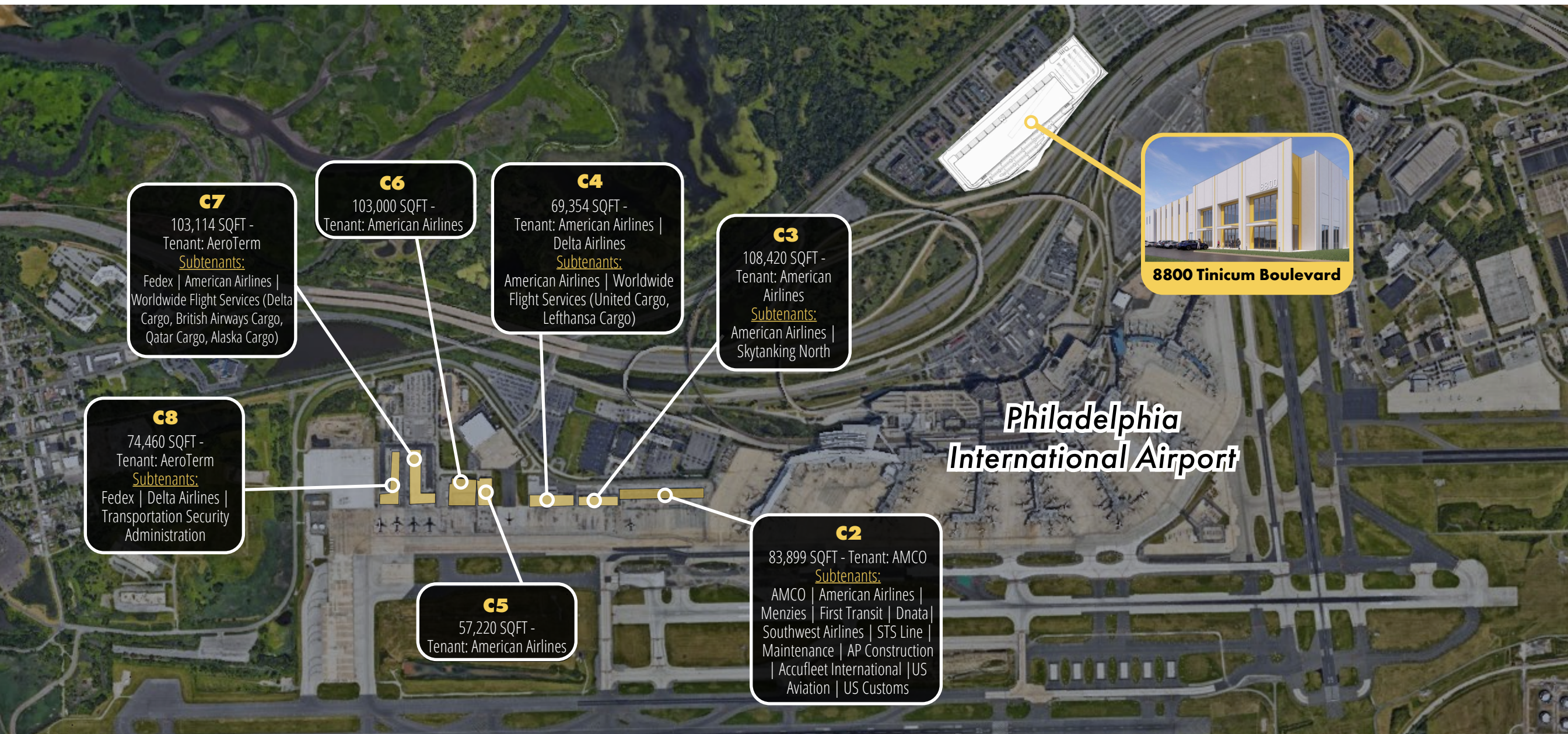

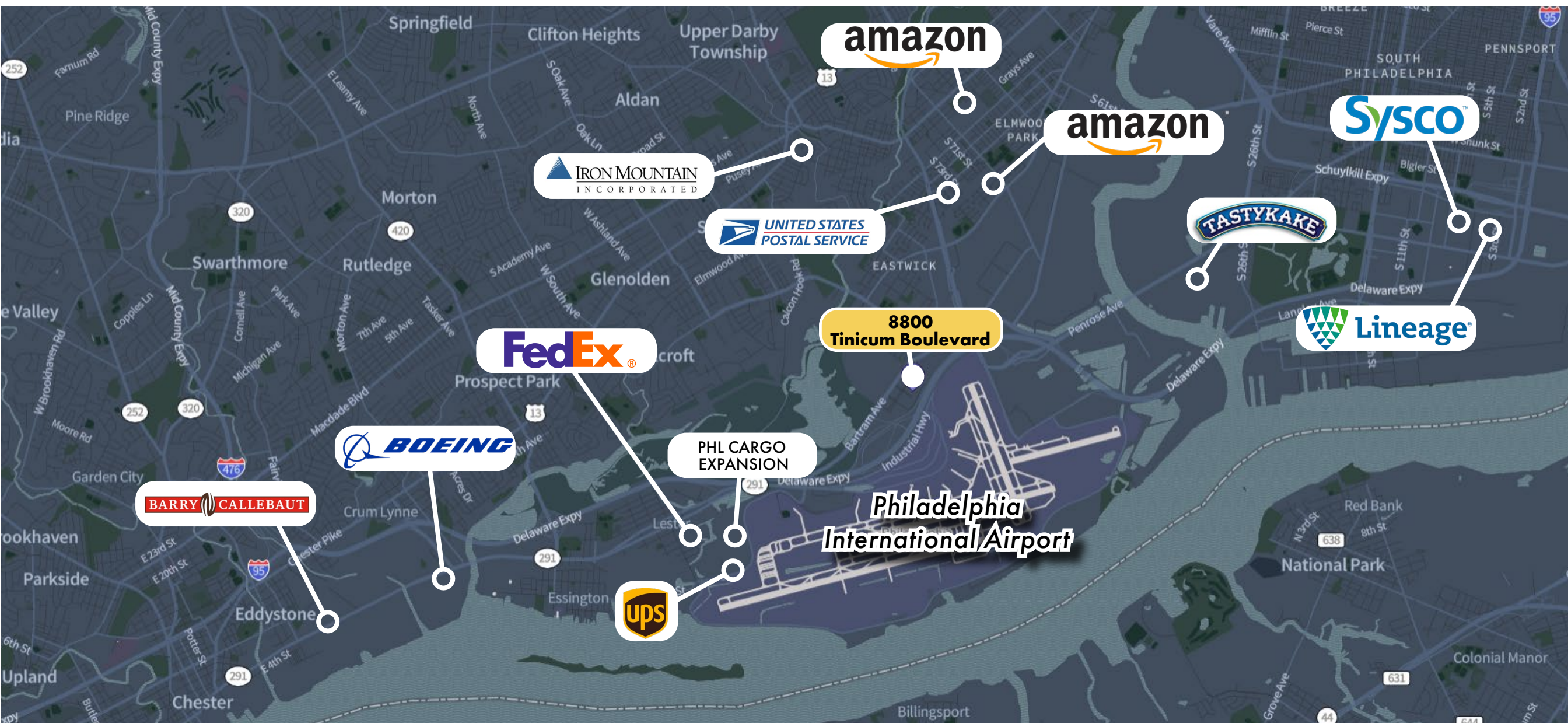


# LABOR ACCESS MAP



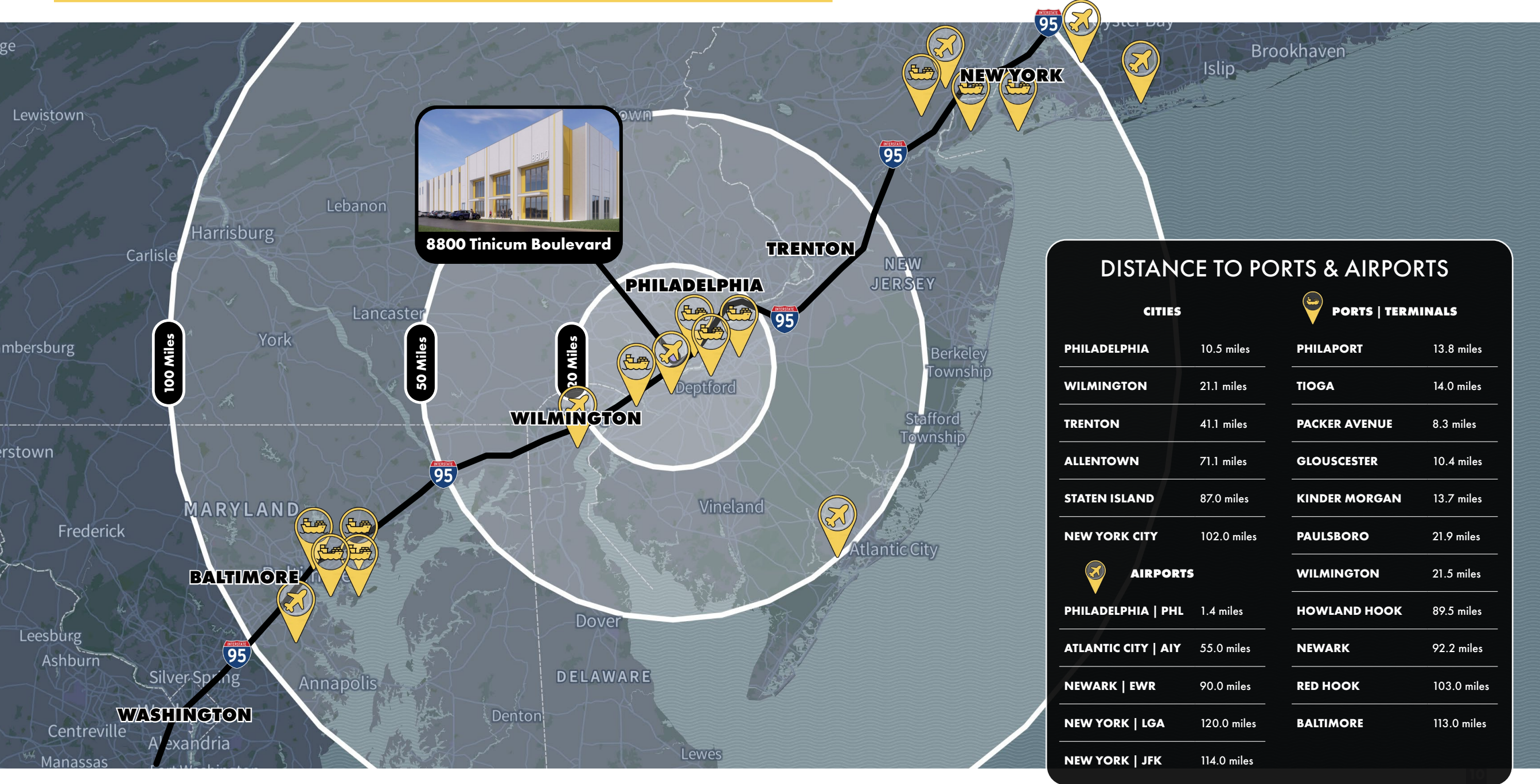
