SANFORD (SANDY) WEINSTEIN, CPA, CGMA

Sanford (Sandy) Weinstein was the longest-serving CFO (Chief Financial Officer/Executive Vice President) in the 104-year history of one of New York City's largest and most respected nonprofits. In that time period, Goodwill Industries of Greater New York and Northern New Jersey, Inc., went from a \$13M organization to approximately \$125M. During his 21 years as CFO, Sandy participated in over 250 Board and Committee Meetings, and presented to the likes of the President of the largest bank in the world at the time, and many other influential people. Sandy played a strategic role in the merger and transformation of the former Goodwill Industries of Greater New York and Goodwill Industries of New Jersey. Besides overseeing Finance, Sandy also supervised the Information Technology and Compliance departments.

Sandy spoke on nonprofit management to five successive classes of graduate students from the United States Army War College. He also testified in front of the New York City Council on behalf of nonprofits. He was interviewed by the Journal of Accountancy, the AICPA's monthly magazine, in May 2009, where he was quoted in regards to his views on the economic outlook and recession.

Sandy is a Certified Public Accountant and is licensed in both New York and Florida. He is a member of both the American Institute of Certified Public Accountants and New York State Society of Certified Public Accountants.

Sandy graduated from Queens College with a B.A. in Accounting, and has a Certificate in Management and Leadership from the M.I.T Sloan School of Management. In addition, Sandy has averaged 40 credits a year in Continuing Education (CPE).

In June 2018, he took over as the President of *EZ Accounting and Tax Services, LLC*, a 30-year-old Accounting and Tax practice located on East Atlantic Boulevard in Pompano Beach, Florida. The firm is now known primarily as **Pompano Beach Accounting and Tax Services, LLC.**, but still also does business under the original EZ Accounting and Tax Services name.

Before working in the nonprofit sector, Sandy worked as a Controller in real estate management and construction, including overseeing the requisition of funding for two residential construction projects in New Jersey for over one hundred million dollars each.

Sandy also has four years of experience in public accounting, including working at a prominent Long Island CPA firm, which has since been acquired by Baker Tilly.

Sandy splits his time between Long Island, NY and Pompano Beach, FL.
