RESOLUTION OF INTENT TO ANNEX OF INTENT TO ANNEX REAL PROPERTY

WHEREAS the Whitewood City Council deems it in the best interest of the City that the below described territory be included within the corporate limits of the City and annexed thereto; and

WHEREAS the Whitewood City Council has determined that Hills Products Group Inc., Hills Materials Co, Hills Materials Inc., Hills Materials Company Inc., and Hills Products Group Inc., are the sole owners of the properties sought herein to be annexed;

WHEREAS the real property is contiguous to the existing boundaries of the City of Whitewood;

WHEREAS the Whitewood City Council has determined that the territory described below, and any residents of that territory share a common bond and community of interest with the City of Whitewood and the annexation of that territory constitutes a natural and reasonable inclusion;

WHEREAS this decision is based on an annexation study pursuant to 9-4-4.1;

WHEREAS based on the aforementioned study, ample and suitable resources exist to accommodate the orderly growth or development of the contiguous territory;

WHEREAS the estimated difference in tax assessment rate for the residents in the contiguous territory is an increase in the mill levy of 6.28;

WHEREAS the exclusions and irregularities in boundary lines are not the result of arbitrariness;

WHEREAS there is reasonable present or demonstrable future need for annexing the contiguous territory;

WHEREAS population and census data indicate that the municipality has or may experience growth or development beyond its present boundaries.

NOW, THEREFORE BE IT RESOLVED by the City of Whitewood that the following territory is hereby included within the corporate limits of the City and annexed thereto:

RESOLUTION TO ABATE NUISANCE AND CONDEMN PROPERTY

WHEREAS on August 8, 2022, a legal action was commenced against Thomas Mraz and real property legally described as

E 90 Feet Of Lots 3, 4, and 5, in Block 16, Town of Whitewood, Lawrence County, South Dakota.

and,

WHEREAS the physical address of the property is 1216 Hooker Street, Whitewood, South Dakota, and,

WHEREAS the action against Thomas Mraz and the real property was commenced to abate the nuisance the real property was creating based on the following facts observed by the City's building inspector:

- 1. The Bldg. currently does not have any utilities going to the property.
- 2. The front porch is falling apart and is unsafe.
- 3. Siding is falling off the home, exposing the underwood causing decay.
- 4. There is an area leading to the Attic that is open for wildlife and others to gain entry to the home
- 5. The foundation to the home has shifted causing the home to be considered unsafe.

- 6. The entire bldg. and surrounding property is deteriorating at a rapid rate causing the current conditions.
- 7. There is a camper on the property with broken windows for wildlife and others to gain entry to the camper.
- 8. Throughout the property there are tires that are breeding grounds for mosquitos with stagnant water in the tires.
- 9. Grass, Weeds, Overgrown Tree Limbs & Noxious weeds are throughout the property.
- 10. Debris throughout the property creating a nuisance on the property. and.

WHEREAS on August 15, 2022, a public hearing was held. At this hearing it was determined to give Thomas Mraz 60 days to bring the property into compliance with the Ordinances of the City of Whitewood, and

WHEREAS Thomas Mraz did not bring the real property into compliance with the Ordinances of the City of Whitewood during the 60 days agreed to, and

WHEREAS, As of the date of this resolution, the property continues as a nuisance,

NOW, THEREFORE BE IT RESOLVED the City of Whitewood authorizes its Attorney to proceed and obtain a final Order from the Lawrence County Circuit Court to demolish the property and permanently abate the nuisance.
