STEP BY STEP FRANCHISE PROCEDURE

SOUTH DAKOTA

- Step 1: <u>APPLICATION</u>: File a written application for a franchise by letter from the region manager to the auditor or clerk. The application should be accompanied by a copy of the proposed franchise ordinance and pertinent forms.
- Step 2: FIRST MEETING: The first meeting of the governing body of the municipality should be held for the purpose of giving the title of the franchise its first reading. Before the first meeting the ordinance should be given a number.
- Step 3: SECOND MEETING: The second meeting of the governing board should be held on a regular meeting date of the council or board, with at least five (5) days intervening between the first and second meetings.
- Step 4 PUBLICATION: The ordinance should be published in its entirety once immediately after its passage and approval by the council or board. The minutes of the second meeting should be published in the official newspaper or newspapers of the municipality.
- Step 5: RECORDING THE ORDINANCE: After the ordinance takes effect, the auditor or clerk should record the ordinance along with a certificate (affidavit) of the date of its publication in the Ordinance Book.
- Step 6: ACCEPTANCE: Within thirty (30) days after Company is notified of passage and final approval of this ordinance, Company shall file its written acceptance of the franchise with the clerk or auditor of the municipality.
- Step 7: RECORD: The record of franchise proceedings should be executed.

Ordinance 2025-01

AN ORDINANCE GRANTING TO MONTANA-DAKOTA UTILITES CO., A DELAWARE CORPORATION, ITS SUCCESSORS AND ASSIGNS, THE FRANCHISE AND RIGHT TO CONSTRUCT, MAINTAIN AND OPERATE WITHIN AND UPON, IN AND UNDER STREETS, ALLEYS AND PUBLIC GROUNDS OF THE CITY OF WHITEWOOD.

A GAS TRANSMISSION AND DISTRIBUTION SYSTEM FOR TRANSMITTING AND DISTRIBUTING NATURAL OR MANUFACTURED GAS, OR A MIXTURE OF BOTH, FOR PUBLIC AND PRIVATE USE.

BE IT ORDAINED

SECTION 1. For convenience, herein, said municipal corporation is designated and referred to as "Municipality" and Montana-Dakota Utilities Co. is designated and referred to as "Grantee." Any reference to either includes their respective successors and assigns.

SECTION II. There is hereby granted to Montana-Dakota Utilities Co, a Delaware corporation, its successors and assigns, subject to the limitations herein stated, the right and franchise to occupy and use the streets, alleys and public grounds of the municipality as now, or hereafter constituted, for the purpose of constructing, maintaining, and operating, within, upon, in and under the same, a gas distribution system for transmitting and distributing natural or manufactured gas, or a mixture of both, for public and private use.

SECTION III. Grantee shall maintain an efficient distribution system for furnishing natural or manufactured gas, or a mixture of both for public and private use at such reasonable rates as may be approved by the Public Utilities Commission of the State of South Dakota and under such orders, rules or regulations as may be issued by a federal or state agency having jurisdiction thereof.

SECTION IV. This franchise shall not be exclusive and shall not be construed to prevent the Municipality from granting to any other party the right to use the streets, alleys, and public grounds of the Municipality for like purposes.

SECTION V. The Municipality reserves any right it may have, under its police power, or otherwise, to control or regulate the use of said streets, alleys, and public grounds by Grantee. This section shall not affect the right of Grantee to receive compensation for the expenses of changing, removing or relocating its facilities located in private right of way. Further, if at any time said Municipality shall vacate any street, alley or public grounds in which Grantee's facilities are located, an alternate route or private property easement shall be provided to Grantee. Grantee shall not be required to relocate facilities when any street, alley or public grounds in which they are located is vacated for the convenience of abutting property owners or another private party and not as an incident to the public improvement, unless the reasonable cost of such relocation and the loss and expenses resulting therefrom it first paid to Grantee.

SECTION VI. Grantee shall indemnify and save and hold the Municipality harmless from any loss or damage due to the construction, installation, and maintenance of its distribution system, and its use of the streets, alleys, and public grounds of the Municipality; however, Grantee shall not be required to indemnify and save or hold the Municipality harmless from loss or damage to the extent such loss or damage is caused by the acts, omissions, or negligence of the Municipality, its employees, assigns, agents, contractors, or other persons under its direction or control.

SECTION VII. Grantee shall have the right to assign this franchise to any party, or corporation, but all obligations hereunder shall be binding upon its successors and assigns.

SECTION VIII. Within thirty (30) days after Grantee is notified of passage and final approval of this Ordinance, Grantee shall file with the clerk or auditor of the Municipality its written acceptance of this franchise.

SECTION IX. This franchise shall continue and remain in full force and effect for a period of twenty (20) years from the date upon which this ordinance shall become effective as provided by law.

2.510 Common Council - Membership - Terms of Office

The common council consists of the mayor who is elected at large, and two aldermen from each ward, who are elected by the electors of each ward for a term of two years, unless a municipality adopts an ordinance establishing the term of office to be three, four, or five years. (SDCL 9-8-4). A person may be nominated, elected, or appointed as a mayor or as an alderman if the person is a citizen of the United States, a voter of and resident of the municipality, and, if an alderman, a voter of and resident of the ward for which the person is to hold office. (SDCL 9-8-1.1)

2.513 Division into Wards - Redistricting


The law provides that municipalities can determine by ordinance their own wards and election precincts for election purposes. There is no minimum or maximum number of wards required, however, an attorney general's opinion states that aldermen are not to be elected at large. (AG Opinion 84-11) However, the 2022 Legislature passed a law allowing municipalities of the 2nd or 3rd class to choose to elect aldermen to the common council at large, following a majority vote at an election using processes provided in SDCL 9-11-6. (SDCL 9-8-4.1) (See Hdbk., sec. 2.700) When determining the number of inhabitants in wards, the last preceding federal census is the rule of thumb. However, the governing body may, by resolution, authorize the finance officer to determine the number of inhabitants by filing a certificate showing the number of persons registered to vote in each ward. That number multiplied by two shall constitute the number of inhabitants until the next federal census. Municipalities should attempt to make all wards of equal size and must notify the county auditor forty-five days prior to any local election of any boundary changes. In even numbered years, the municipality must notify the county auditor one hundred days prior to the primary election and the general election of any boundary changes. (SDCL 9-13-16; 9-2-7; 12-14-1; 12-14-1; See Hdbk., sec. 2.715)

2.515 Vacancies

When a vacancy exists on a municipal governing body, the remaining members shall appoint a replacement to serve until the next annual municipal election or the vacancy may be filled by special election for the remainder of the unexpired term as provided in SDCL 9-13-14.2. In the aldermanic form of municipal government, the appointment must be a person from the same ward of the municipality. If electing a person to fill the remainder of the unexpired term at an annual municipal election, the vacancy shall have occurred prior to the publication required by SDCL 9-13-6. (SDCL 9-13-14.1; See Hdbk., sec. 5.350) When a vacancy exists in the office of mayor, it shall also be filled by appointment by a majority vote of the aldermen or by special election. (SDCL 9-8-2; See Hdbk. Sec. 5.385)

The governing body of any municipality may, by ordinance enacted prior to the vacancy, require that any vacancy on the governing body or in the office of the mayor is to be filled by a special election called for that purpose to be conducted as provided in SDCL 9-13-14 and this section. No such special election may be held less than ninety days before the annual municipal election. The finance officer of the municipality shall publish a notice in the official newspaper of the municipality stating that a vacancy exists, that the vacancy will be filled by special election, the date of the election, and the time and place where nominating petitions may be filed for the office. The notice shall be published once each week for two consecutive weeks beginning at least sixty days before the date of the special election. Nominating petitions for the vacancy shall be prepared and filed as provided in SDCL 9-13-7, may not be circulated more than sixty days before the date of the special election, and shall be filed at least thirty days before the date of the special election shall be published as provided in SDCL 9-13-13 and 9-13-14. (SDCL 9-13-14.2)

In cases where a member of the governing body is called to serve in active duty, that member may temporarily resign and a temporary replacement may be made. The replacement serves until the original member returns from active duty or until the expiration of the member's term, whichever occurs first. (SDCL 3-4-8)


Good Morning, Jessica:

The city is required to identify 100% of its service lines, including the customer portion. Should any part of the line remain unknown, the system will be required to send annual public notices to that customer, explaining that their service line is unknown. Additionally, if a system has unknown service lines (either the system-owned side or the publicly owned side) on 11/1/2027, the system will be required to submit a plan to identify all the unknowns by 2037.

Therefore, we developed an online survey tool for water systems that enables customers to self-identify their service lines. While using the tool is optional, identifying the service lines is mandatory. If you have an alternative method for visual verification or tap records, those approaches would be adequate.

Regarding documentation, I have attached the EPA's Lead and Copper Rule Improvement, which outlines the requirements starting in 2027. We are currently operating under the LCRR, which requires the initial inventory to be submitted by 10/16/2024 and mandates annual public notices of service line material.

The next requirement in addition to the public notices is the replacement plan- for your case it would consist of a plan to identify all unknowns. The reality is, if a customer refuses to tell you what their service line is and the house was built prior 1988, and you have no tap cards— it is their choice and the line remains "unknown".

However, administratively the burden will be on the city. The city will have to prove in their replacement plan that it does not have access to the service line—think of meters— are Whitewoods meters in the customer's house—if the city doesn't have access, you would have to document 4 attempts each year through 2 separate methods that you attempted to identify the line and the customer refused.

Ultimately, it is the customers choice. However, the city should be prepared to continue to hard copy mail public notices each year until 2037 and onwards and then in 2037 begin documenting 4 attempts to contact the customer.

Between now and then, if the city has any meter replacement projects which allow for the customer portion of the line to be identified, or any other public works project that requires curb stop replacement - the city should use those routine operations as a way to verify/document the customer portion of the service line. In these instances, the customer doesn't need a photo. The City worker or contractor would document what they saw and send that information to you, where you could just update the inventory.


