### Sharps Disposal

5L containers, 23L pails, 1.5L containers and wall brackets (5L or 1.5L sizes), 23L pails for Pharmaceutical

**X-Ray Processor Waste:** Fixer / Developer (20 L containers)

**X-Ray Film:** Credit is issued for weights over 100lbs. To receive credits, please sort the x-rays from client envelopes and place in boxes or we can supply bins. We will pick up unsorted film, however there will be no credit issued.

### Amalgam / Lead Foil

Non-Contact Amalgam / Capsules, Bridges and crowns

Solids from vacuum particle traps & contact amalgam are placed in a 1.3L container

New SolmeteX Hg5 amalgam filter and Spent SolmeteX Hg5 filter disposal

Lead Foil 1.8 L container and Lead Aprons

Spent Particle Trap disposal, New Particle Traps (box of 8) and Reconditioned Particle Traps (box of 8)

### Document Shredding

100 liter sized drum, 200 liter sized drum and Banker Box

Containers are supplied by Greenflow. Call **1-800-287-5416** and a service technician will pick up each full container and leave an empty replacement (if required). To reduce your carbon footprint, have all waste and recycling picked up together. *Please note: a larger transportation fee may apply outside 100 km radius of Burlington.* Pricing is subject to change without notice.

### FREE E-Waste / Batteries / Toner and Ink Jet Cartridges

If you have old x-ray machines, computer towers, laptops, televisions, fax machines, monitors, printers, photocopiers etc., add them to a scheduled pick up

### Light bulbs (fluorescent/CFL/sodium/incandescent/LED...)

Unfortunately, most fluorescent light bulbs end up in a landfill or incinerated, releasing mercury when the bulbs are broken. Every part of a fluorescent light; from the glass tube to the mercury inside can be recycled and reused

**HWIN Management Program:** Hazardous or non-hazardous wastes generated from a single doctor's office or a single dentist's office is excluded from being manifested. If there is more than one dental practitioner in the office and each dentist is consolidating hazardous or non-hazardous waste for disposal; the office must register their location and their waste with The Ministry of Environment and Climate change at [www.hwin.ca](http://www.hwin.ca). The majority of dental offices may be exempt from manifesting waste, but never the safe handling and proper disposal of hazardous or non-hazardous wastes.
