

Dental practices with more than one practitioner that generate regulated or non-regulated hazardous waste must have an Ontario Waste Generator Number. The number is obtained by registering on the Ministry of Environment, Conservation and Parks website <u>www.hwin.ca</u>. Once a dental practice has registered and issued a generator number, the number must be renewed annually. MOECP deadline for renewals is February 15, 2020.

Note: The program includes all administrative requirements throughout the calendar year. This includes any aide in adding waste classes or removing ones that are no longer generated. *Please be sure to let us know at the time of renewal if there are any wastes you are no longer generating so we may update and clean up your account.* 

HWIN is an automated system that sends quarterly updates via email to your company official on the account regarding accumulated fees. It is an accepted practice by the M.O.E. to allow these fees to accumulate throughout the year to be paid at the same time of the annual renewal. It simplifies the process for all. For this reason, our policy is to follow the program in this manner. You are required as a participant in this program to forward emails you receive from the HWIN Helpdesk so we are aware of the activity, and permitting us to make any adjustments required.

Manifest and tonnage fees that are incurred by a waste management service provider other than Greenflow Environmental Services Inc. are NOT included in the program and will be added to my fee.

It remains the sole responsibility of the Generator to manage onsite waste streams and to notify Greenflow of any changes.
