Declaration of Candidacy Saxman I.R.A.

Election Date: April 24, 2025

Who can file for candidacy?

You may file for office if you are a qualified voter of the Organized Village of Saxman. *Please read the Constitution and By-Laws for further eligibility requirements.

When is the deadline for filing?

You can file for office starting on March 1st, 2025; the deadline is April 14th, 2025, at 12:00 p.m.

Where and how do I file for candidacy?

Please call the Tribal Office at (907) 247-2502 if you have any questions. Candidacy forms can be picked up at the Tribal Office at 2706 S. Tongass between 8:00 a.m. and 5:00 p.m., Monday through Friday.

Instructions for Completing the Declaration of Candidacy Form:

1. Print your full legal name.
2. Select the seat you are intending to run for.
3. Print your residential and mailing addresses, and please provide your phone numbers.
4. Indicate your text message communications preferences.
5. Providing your email address is not required.
6. Select "Yes" if you authorize the Tribal Administrator's Office to publicize your phone numbers.
7. Print your name clearly and exactly how you want it to appear on the ballot. *Honorary or assumed prefixes will not be included.
8. Provide your official signature, print your full legal name, and record the signature date.
9. Accept and acknowledge the oath and procedures and agree to the background check requirement.
10. Please note that the Tribal Office will require all candidates to provide one form of legal identification, such as a passport, hunting or fishing license, tribal membership card, or State of Alaska-issued driver's license.
