CCTHITA (Tlingit & Haida) WITHDRAWL - Deferred

President Joe Williams stated he is waiting for answers to questions presented to KIC President Norman Skan. Layla Kelly stated she will be reaching out to try to obtain the answers to the questions discussed at the OVS Workshop on November 20th. Tribal Administrator stated he will draft a letter to request answers. The Council concurred to have this deferred until all the answers are provided.

8 NEW LETTERHEAD

President Joe Williams requests to remove the Council information on right-hand side of the letterhead. The Council requested to keep as is after removal of information and just to add the saxmanira&kpunet.net email underneath picture for point of contact.

10 REQUEST TO AID WRANGELL FOR LANDSLIDE

Motion/Second Claudia Boyd and Trudi Swink to approve \$1,000 in aid to Wrangell for the disaster with the landslide that occurred. Funds would come from Small Tribes Grant (STG). Council expressed their sadness in this situation but in the past there was a situation when Prince of Wales had a disaster and no offer was made to help them. In the event Saxman has a disaster Council felt assistance must be given to Saxman before giving to others. It was felt if you give to one a precedent is set and you have to give to others. Also the STG is to be used for Tribal administrative expenses.
