Pool safety is important to review each year. Taking practical steps to prevent child drownings is important for all families, especially those with a child who faces a heightened risk – such as a child with special needs.



Pool Safety Tips





PARENT'S CORNER

FYI from one of our Parents:

Not sure if you have been made aware of these **Virginia learning acceleration microgrants**, but all K-12 children qualify for \$1500 and up to \$3000 if income level is less than 300% of the poverty line. The age is lower for children with documented disabilities (I believe 2 and up). The funds can be used for:

Tutoring in core content areas (English reading/writing, mathematics, science and history/social science) and foreign languages required to meet graduation requirements. Tutoring may be in-person, virtual or hybrid, and in one-on-one, small group or large-group settings.

Purchasing of assistive technologies specified in a child's Individualized Education Plan or 504 Plan.

Specialized educational therapy services and supports, including speech language therapy, specialized reading instruction and other services provided by a licensed practitioner.

The application was very easy and fast. For individuals who are under the age but have a disability a doctor's note is needed (I just used Clem's diagnosis paperwork we had from Kaiser and the state accepted that).
