

ARTICLES OF INCORPORATION

OF

SOMERSET HILLS III HOMEOWNER'S ASSOCIATION



The undersigned, a natural person of the age of 21 years or more, acting as Incorporator under the Oregon Non-Profit Corporation Act, Chapter 61, Oregon Revised Statutes, adopts the following Articles of Incorporation:

1.

The name of this Corporation is Somerset Hills III Homeowner's Association, and its duration shall be perpetual.

11.

The purpose or purposes for which the Corporation is organized are:

a. To engage in any lawful activity, none of which is for profit, for which corporations may be organized under Chapter 61, Oregon Revised Statutes.

111.

The number of Directors constituting the initial Board of Directors of the Corporation is three and the names and addresses of the persons who are to serve as Directors until the first annual meeting of the members or until their successors are elected and shall qualify, are:

The address of the registered office of this Corporation shall be 366 East 40th Avenue, Eugene, Oregon, and the name of its initial registered agent at such address is John F. Breeden.

The name and address of the Incorporator is: John F. Breeden, 366 East 40th Avenue, Eugene, Oregon 97405.

At least 85% of the income of this Corporation shall consist of the amounts collected from the members of this Corporation for the sole purpose of meeting losses and expenses of operating this Corporation. No part of the income of the Corporation shall be distributable to its members, directors, or officers. This corporation shall not have or issue shares of stock and no dividends shall be paid; no part of the income of the corporation shall be distributed to its members, directors or officers; no loan shall be made by this corporation to its directors or officers. The directors of this corporation who vote for, or who assent to the making of a loan to a director or officer of the corporation, and any officer or officers participating in the making of such a loan shall be jointly and severally liable to the corporation for the amount of such loan and for the repayment thereof.

In the event of the dissolution of this Corporation, the assets of the corporation shall be distributed as follows:

All liabilities and obligations of the Corporation shall be paid, satisfied and discharged.

Sums collected from members as assessments which have not been used shall be returned pro-rated to members of record as of the date of dissolution. The remaining assets, both real and personal, of the corporation shall be dedicated to an appropriate public agency to be devoted to purposes as near as practicable the same as those to which they were required to be devoted by the Corporation.

In the event such dedication is refused acceptance, the assets shall be granted, conveyed and assigned to any non-profit corporation, association, trust or other organization to be devoted to purposes and uses that would most nearly reflect the purposes and uses to which they are required to be devoted by the corporation.
