

TO FSEA CENTRAL DISTRICT LODGES

It has been brought to my attention that members in several of our Lodges have been distributing unsolicited information containing solicitous and political information by posting them on lodge bulletin boards and sending emails containing this information to members. In fact, some have received this even after advising they did not like or want the information.

This must stop IMMEDIATELY! It is prohibited by Grand Lodge Statutes and will not be condoned. It is a violation of your Obligation, in addition to subjecting members to further punishment in violation of other statutes including Chapter IX, Sections 9.060 © and 9.070 (j). Times are extremely volatile now and we as Elks will respect the feelings of our fellow members. Actions such as this can tear our Lodges apart and cause a loss of members.

Under the authority granted me by Executive Order No. 19-152, I am directing all our Lodges to abide by the Rules, Statutes and Regulation of our Order and immediately cease and desist publishing, distributing and/or posting any such material in our Lodges. Any further violations of this sort will be subject to further punishment as provided for in the Grand Lodge Statutes.

I further direct that this letter be read at the next scheduled meeting, posted in your lodge and published in your next Lodge bulletin. Please notify when this is accomplished.
