CSDED Project Close Outs & Completions

In the last month, the City of Blunt closed out on their Drinking Water System Improvement Project that was funded by DANR. The Cities of Pierre Water Treatment Plant, Onida's Phase II drinking and Wastewater Improvement Project, and Fort Pierre's Wastewater Treatment Upgrades have reached completion of project work and are working toward closeouts. The Hughes County Employee Policy update is awaiting approval by the Hughes County commission and the 2023 Brownfield Survey report has been submitted to DANR for review.



Funding Awarded:



Congratulations to the Cities of Philip and McLaughlin who have been awarded funding for infrastructure projects. The City of Phillip was awarded \$770,000 from GOED from the CDBG funds for water system improvements and \$1,040,830 CWSRF funds from DANR for improvements to wastewater and storm sewer infrastructure. The City of McLaughlin was awarded \$770,000 from GOED from the CDBG funds for drinking water improvements. We look forward to working with you on these projects. Multiple communities were awarded funding through SD Department of Health's West Nile Prevention Grants: Blunt \$1,779, Eagle Butte \$4,000, Fort Pierre \$3,077, Hughes County \$5,000, Interior \$600, Isabel \$1,296, Kadoka \$982, McIntosh \$1,461, Onida \$2,742, Phillip, \$2,500. Pierre \$15,000, Stanley County \$3,000, and Timber Lake \$2,422.

Governor's House and Housing



The Governor's House Program within the boundaries of Central SD Enhancement District has seen three houses placed this summer. While these houses were around the Pierre area many will be placed in other locations in the coming years. This is exciting news. There are several development corporations/non-profits and developers that have taken on the challenging housing needs in central SD by purchasing Governor's Houses to place in their communities for homeowners to purchase. While it's not large scale like what you see to the east and west of central SD it's still a big deal in our smaller communities.

For-profit developers and not-for-profit developers may purchase up to two Governor's Houses a quarter to be sold to a homeowner who meets the qualifications of the Governor's House Program. The profit from the Governor's Houses is capped at 10% of the project cost to keep the integrity of the programs purpose. These Governor's Houses could also be rented to tenant(s) who also meet the eligibility criteria for the Governor's House Rental program.
