CEDS Update

On September 22, the Comprehensive Economic Development Strategy Committee met to dive into the survey findings deeply. Our weaknesses are in our housing, workforce, and population, with other concerns among the top. Our opportunities within our region lie within our weaknesses of creating new housing opportunities, new business growth, and communities having a need. Thankfully, the communities and leaders within our region recognize a need to address these findings and are inspired to discuss these issues and create a plan of action. Building Resilient Infrastructure and Communities Program

The SD Office of Emergency Management (OEM) is currently accepting applications for BRIC FY22. The Building Resilient Infrastructure and Communities (BRIC) program makes federal funds available to states, U.S territories, federally recognized tribal governments, and local communities for hazard mitigation activities. It does so with a recognition of the growing hazards associated with climate change, and of the need for natural hazard risk mitigation activities that promote climate adaptation and resilience with respect to those hazards. These include both acute extreme weather events and chronic stressors which have been observed and are expected to increase in the future.

Subsequently, a total of \$2,000,000.00 of funding is now available for local governments and certain private-non-profit organizations to apply for hazard mitigation projects that will reduce the loss of life and property by lessening the impacts of future disasters.

Past mitigation projects include drainage studies, home acquisitions, powerline burials, road raises, generators on critical infrastructure, drainage improvements, culvert improvements, pre-disaster mitigation plans, and tornado safe rooms. To see more past mitigation projects in SD, visit OEM's mitigation website, https://dps.sd.gov/emergency-management/mitigation, and scroll to the bottom where you can click on "South Dakota Mitigation Projects Map" under the resource section. Application time frame:

December 1st, 2022: Applications are **due** to the State Office of Emergency Management (SD OEM) using the new digital platform, FEMA GO; it is highly encouraged and welcomed to submit applications prior to this deadline.

December 2022: SD OEM reviews all applications; late or incomplete applications will not be considered for funding.

January 28th, 2023, by 3:00PM EST: SD OEM must submit OEM approved applications to FEMA Region VIII.

FEMA Region VIII has up to one full year to award projects (January 2024) although award announcements are expected by Fall 2023.

Project cost shares are as follows: 75% Federal Match / 10% State of SD OEM Match / 15% Local Applicant Match.

Sub-recipients will be eligible for up to 5% of the project award amount for management costs.

Member Spotlight

Fort Pierre Wastewater Treatment Facility Improvement Project

The City of Fort Pierre operates a wastewater treatment facility consisting of six (6) lagoons with a combined surface area of approximately fifty acres. The lagoons are a natural method of treating wastewater by using the sun, wind, and naturally occurring organisms to remove the chemicals and organisms that are harmful to wildlife and humans.

This method has limitations. The colder temperatures of November through March reduce some of the organisms' activity, thus reducing the ponds' effectiveness. With the steady growth of Fort Pierre, the loss of

effective treatment has caused the City to be in violation of the SD Department of Agriculture and Natural Resources requirements. Therefore, the City and SDDANR developed a project to improve the effective treatment of the wastewater regardless of the temperature and weather conditions.

The project consisted of reorganizing the flow of the wastewater through a sequence of ponds to create a steady treatment process. Aeration was added to the leading ponds to enhance the first phase of the treatment process. The project also included the installation of



a Moving Bed Bio Reactor (MBBR) to remove the ammonia from the wastewater. Although ammonia is a naturally occurring substance, in high concentrations can be harmful to fish, wildlife, and humans. The MBBR contains additional aerators and media for the organisms that remove the ammonia from the wastewater. The media, in this case, is about the size of a quarter and has a Styrofoam consistency. The media has many voids and holes that the ammonia-removing organisms attach to and grow. The media is in constant motion around the MBBR, propelled by aeration, bringing the organism to the food and the food to the organism.

The project included one last step to finish treating the wastewater. The final step is ultraviolet disinfection. Ultraviolet light is natural disinfection. In high concentrations, ultraviolet light can quickly kill any remaining bad bacteria and organisms in the wastewater. A special tank was installed that allows for the high concentration of ultraviolet light to penetrate the flowing wastewater killing any remaining bad organisms and bacteria before the wastewater is released back into the natural waterways.

The project is fully operational, with only a few minor items to complete. With this project in place, Fort Pierre can continue to grow and prosper.
