CEDS Approved

On April 22, 2025, the 2024-2029 Comprehensive Economic Development Strategy (CEDS) was accepted by the Economic Development Administration (EDA). The CEDS provides a regional blueprint for communities, businesses and investors to respond to the economic needs of the region in a strategic and purpose driven manner. In the past five years \$2.6 million in competitive EDA funding has been made available to communities within the Central SD region. Because of your continued collaboration with the Central SD Enhancement District our region is able to implement the CEDS to build a stronger economy.

EDA NOFO

On June 4, the US Economic Development Administration (EDA) announced the Notice of Funding Opportunity for their FY 2025 Disaster Supplemental Grant Program. The FY 2025 Disaster Supplemental Grant Program makes approximately \$1.45 billion in available funding; the program is designed to support disaster recovery efforts in major disaster occurring in calendar years 2023 and 2024. This funding opportunity is not just about rebuilding it's about transforming local economies after disaster, with an emphasis on improving communities' economic outcomes and resilience to future disasters. The program aims to aid communities in implementing long-term economic recovery strategies through various construction and non-construction projects.

Funding Opportunities:

July 15th marks the application deadline for three funding opportunities through SD Department Transportation.

The **Community Access Program** provides funds on a competitive basis to communities with populations under 5,000 for use in new projects involving the repair or replacement of important local roads such as the road to the elevator, to the school or hospital, and in the main business district.

The Industrial Park and Agri-Business Grant Programs provide funds to assist communities who have a new industry or agri-business and need new or expanded access to the facilities.

Industrial Park and Agri-Business applications will be considered three times each year. These applications are due April 15th, July 15th, and October 15th of each year. The applications will then be reviewed by SDDOT as well as the Governor's Office of Economic Development before being considered at the Transportation Commission meetings. Only applications for projects that have not been constructed will be considered. Please reach out to CSDED for assistance with the applications for these programs.

Governor's House and Housing

On April 9, 2025, the South Dakota Housing Governors Program adjusted the household income to qualify for the Governors House Program. This is an annual adjustment made to align with the 70% state median income formula set within the provisions of the program. State median income is adjusted annually by HUD which is based on the American Community Survey.

To qualify, purchasers must:

- Make \$71,540 or less in a one- or two-person household or \$81,760 or less in a household of three or more
- Have net worth of less than \$125,000—or \$105,000 in liquid assets—for applicants age 61 or younger
- Have net worth of less than \$250,000—or \$140,000 in liquid assets—for applicants age 62 or older
- Consider the home their only residence
- Place the home within South Dakota

On May 13, 2025. SD Housing Governor's House Program adjusted the pricing of the Governor's House, Governor's Daycare and DakotaPlex to handle the increase in the cost of production and delivery those prices are:


- 2-bedroom Governor's House \$86,000.00
- 3-bedroom Governor's House \$96,000.00
- Governor's Daycare \$96,000.00
- 2-bedroom DakotaPlex unit \$97,000.00
- 3-bedroom DakotaPlex unit \$106,000.00
