give my permission for a licensed veterinarian to administer the medical treatment deemed	necessary, including anesthesia. I
understand every effort will be made to contact me in such an event. I understand I am fully	y financially responsible for any and al
costs resulting from veterinarian care. In case of emergencies, DOG TAG will take my dog(s	s) to my veterinarian, or if
unavailable, an emergency veterinary service for any treatments deemed necessary. In the ra	are and unfortunate event that your
pet dies in our care your pet will be taken to your designated veterinarian and maintained for	or pick-up or further instruction. I
agree not to file legal charges against DOG TAG, the staff or owner for any injury, death or	loss of dog. I hereby release DOG
TAG, its staff or owner from all liability for any injury, death or loss of my dog while in the	custody of, or on the grounds
surrounding DOG TAG facilities. If my dog attends daycare and boarding, I understand that	at the dogs may be corrected verbally,
restricted from other dogs or put on a leash for misbehaviors such as aggressive barking, over	r arousal, growling and snapping at
other dogs or people. I provide permission to crate my dog(s) if necessary. I understand the	concept of dog day care is to socialize
dogs by allowing them to interact with other dogs and people. All reasonable precautions are	e taken to safeguard the health and
physical well being of the dogs staying at DOG TAG for boarding and day care. I understar	nd that the fence around DOG TAG is
6 feet tall and certain dogs can jump over or climb over a fence of this type. I understand th	at there are certain risks inherent in
leaving my $dog(s)$ in the custody of DOG TAG and that with the interaction of dogs there is	s a chance of injury. I hereby expressly
and forever generally waive, discharge claims, indemnify, release from liability, save, hold has	rmless and defend and covenant not
to sue DOG TAG, and their invitees, sponsors, advertisers, owners, officers, directors, emplo	oyees, volunteers, agents, leasors, and

agreement is held to be invalid or unenforceable, that the remainder of this agreement shall	remain in full force and effect. I agree
that it is intended that all terms of this agreement control despite any particular statute or la	w that would otherwise protect me or
my $dog(s). \ I$ hereby represent that I assume all financial liability for the actions of my $dog(s)$	and agree to maintain personal
liability insurance or financial resources adequate to pay for any injury or damage which con	uld be caused by my dog(s) while in
