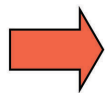

- Pre-Existing Medical Condition Exclusion is waived if a group participant pays the plan cost at or before his/her final payment for the trip, and they are medically able and not disabled from travel at the time payment is made.

## Plan Initiation and Guidelines...

If you are authorized to offer TravelSafe Insurance, simply email [group@travelsafe.com](mailto:group@travelsafe.com) requesting the necessary paperwork that needs to be completed in order to request approval to insure your group. You will need to receive approval for the group before offering the coverage to the clients. Once the group is approved and set up in the system, we will advise, and then you will be able to log into your portal to download the Excel template to enter your traveler's information. Once a group is approved, the same rating system applies to all travelers, regardless of when they join the group. Optional benefits incur additional costs. If you are not currently authorized to offer our TravelSafe products, please call us at 1-800-523-8020.

1. Travelers should be added at the time their plan cost(s) are received by you.
2. Groups may only be enrolled online and travelers added prior to payment for the group.
3. Prior to payment for the group, you may add, delete or change traveler information.
4. Payments for the entire group must be made by one credit card.
5. For plans with a Trip Cancellation benefit (Necessities and Most Necessities), we recommend insuring the full trip cost.
6. Groups are defined as 10 or more insured persons with a common interest traveling to the same destinations with common group departure and return dates. Individual travelers may leave before the group departure date or stay beyond the group return date.
7. Payment for the group must be received by TravelSafe 15 days prior to the scheduled group departure date.
8. Travel Documents are provided online for you to distribute to group participants. You are responsible for providing travelers with a copy of the plan document upon purchase of the plan.

## How to calculate group pricing?

(Note - agent portal will do all your plan cost calculations)

Example - \$1,200 Trip Cost for a 35-year-old for Necessities Plan with CFAR - Percentage is 7.5%  
 $\$1,200 \times 7.5\% = \$90.00$  plan cost
