What is FACT?

FACT is Monroe County's integrated entry point to care for our community's highest needs/ highest risk children and youth, incorporating the Monroe County Office of Mental Health, Office of Probation – Community Corrections and Department of Human Services.

Why FACT?

- We understand that children who come in contact with higher level systems, such as Juvenile Justice, Child Protective Services or Hospitals, often have unidentified or unmet needs.
- •Our goal is to prevent youth with Behavioral Challenges from getting involved with higher level systems.
- •FACT strives to empower families to work through their challenges using natural supports and our collective knowledge, experience and connections.

What does FACT do?

The Family Access and Connection Multidisciplinary Team is a center of excellence and convener in determining precision of fit and acuity of need, with regard to intervention(s) within family, community systems and collaborative partners.

1) An entity that serves youth and families who present with complex issues. Staff respond to

clients and collaborate to provide a tiered response.

2) Immediate, strength based & trauma informed assessment of highest need youth and families and appropriate referral and linkage to an expanded network of collaborative partners.

3) Sophisticated responses that promote stabilization of youth and families with a focus on community based supports to avoid petition to family court and the use of congregate care.

Who should call FACT?

Parents or guardians can call FACT if they need support with their school aged children who are exhibiting a pattern or challenges with the following behaviors:

- » Family conflict
- » Leaving home without permission, violating curfew
- » Struggling with school placement or performance
- » Acting out aggressively or not following rules at home
- » Stealing, trespassing, vandalism, gang involvement, sex trafficking
- » Using drugs and alcohol
- » School attendance concerns



School districts can submit truancy referrals with FACT. Our team is also available to consult with districts and families regarding student needs and assist them in implementing a plan to address school related concerns.
