Island Green's CSA assists all POAs in Island Green in collectively communicating with Horry County to ensure the planning for our future roads and stormwater infrastructure are adequate to provide for the needs of Island Green's residents. Island Green's CSA is planning for a future in Island Green where all POAs cooperate to provide for the maintenance of our roads and stormwater when the residential development of the land that was the golf course is completed. The Island Green CSA has regular monthly meetings on the second Friday of every month at 11:15AM at Arms Wide Open Church.
