

Purpose: The Bi-County Fair Board will provide scholarships to assist deserving Cibola and McKinley County 4-H members in pursuing undergraduate, vocational, and certificate opportunities.

The Award: The Bi-County Fair Board Scholarship Committee will make available funds at their discretion to award to outstanding Bi-County Fair participants. If suitable applicants do not apply, The Bi-County Fair Board Scholarship Committee reserves the right not to fund any or all scholarships. The scholarships will be available annually if the scholarship fund can handle the output. Funds will come from donations allocated explicitly to the Bi-County Fair Board Scholarship Fund. Applicants may only receive the scholarship once.

Requirements:

- Be a graduating high school senior in Cibola or McKinley County.
- Have at least a cumulative 2.0 GPA.
- Exhibited two of the last five years at the Bi-County Fair and be a 4-H member in good standing.
- Complete an application
- Provide two letters of recommendation. One letter must come from the fair community. (i.e., County Extension Agent, Club Leader, Fair Board member)
- Official High School Transcripts
- Interview- Can be conducted in person, by phone, or through a computer application.
- *The Bi-County Fair Board Scholarship Committee will review all applications. Considerations include but are not limited to Fair participation, thoughtfulness, and completeness of the application.
- *Applications must be typed and completed by the applicant.

Payout: Upon receipt of registration at a college, vocational, or certificate program, the award money shall be distributed. Funds awarded are to be utilized for tuition, books, housing, and other program-related costs. Payout will require proof of enrollment.

Oversight: The Bi-County Fair Scholarship Committee will report to the Bi-County Fair Board. The committee will consist of at least three members in good standing. Committee members will not serve during years that a child or family member will apply for scholarship consideration. Committee members will utilize common rubrics to score all applicants individually. The committee will then combine rubrics and complete the scoring together. The committee reserves the right not to reward scholarships if the applicants do not meet requirements.
