APPLICATION PROCEDURE FOR VILLAGE WATER/SEWER/REFUSE SERVICES:

Please visit the Water Office to make application for Village Services. Applicant must come in person and application should be completed at least 1 business day prior to the need for services. The following information is required for application:

- 1. Applicant information and identification (Driver's License).
- 2. A two hundred-dollar (\$200.00) deposit is required by the person making application for service.
- 3. Reference information: name, address and telephone number of a person not residing in the residence.
- 4. Valid contact telephone numbers.

BILLING & PAYMENT INFORMATION:

- 1. Cash, check, money orders & ALL MAJOR CREDIT CARDS (2.95% fee applies) accepted in the office OR sign up for Automatic Payments (no fees) ask us how!

 **Bills can be paid online at www.adaoh.org. A \$1.25 web fee will be applied to online credit card transactions.
 - (FEES APPLY 2.95% for any card payments and a flat \$1.50 for E-Check option)
- 2. The applicant is responsible for payment of the bill.
- 3. Water payments are due on the 10th of each month by 11:59 pm and any remaining balances are subject to a 5% late charge, per Codified Ordinance 925.20.
- 4. You should receive a bill around the 1st of the month. If you have not received your bill in the 1st week, call our office. *Failure to receive a bill does not waive late penalties*.
- 5. The utility bill is a monthly bill. The readings that appear on the bill are actual readings, not calculated charges. * Exception: extremely cold weather.

 Refuse service may also be included in your bill. Rumpke is the current contract holder for the Village refuse service. You will be responsible for the recycling bin and tote.

- 6. When you are ready to move, please notify our office so the account can be taken out of your name and the process for the deposit refund can be completed!
