As part of the Opioid Settlement, Forsyth County will receive more than \$20 million over an 18-year period. A Memorandum of Agreement between the state of North Carolina and local governments direct how opioid settlement funds are distributed and used in this state. Forsyth County has elected Option B which may involve funding strategies from the Exhibit A list, or a longer list of strategies found in Exhibit B. Funds shall be used to respond to the negative impacts of the opioid epidemic to Forsyth County residents through implementation of high-impact strategies.

APPROACH

B.1. Provide a concise description of the proposed project/program, indicating specifically how County funds will be used, and the timeline for implementation if funding should be approved. Briefly, what are the goals/objectives of the project/program?

Into the Wild (ITW) is a transformative adventure recovery intensive outpatient program (IOP) designed to support women on their journey to recovery from substance use disorder (SUD). ITW especially welcomes women receiving Medications for Opioid Use Disorder (MOUD).

Adventure recovery, also known as adventure therapy, experiential therapy or wilderness therapy, is an innovative approach that utilizes outdoor activities and experiential learning to promote personal growth, self-discovery, and healing. These activities, combined with other evidence-based and trauma-informed therapy, provide a unique and powerfully effective approach to treating those with SUD.

Funds will be used to provide (3) 6-week IOP sessions in 2024. Funds cover wages, food and utilities the cost of insurance. IOPs will take place between the months of March - October 2024.

Participant goals include:

- * Learn self-regulation practices, stress management and coping skills
- * Increase confidence, self-esteem and communication skills
- * Increase trust, empathy and compassion
- * Increase agency and personal responsibility
- * Increase connections to others/personal network and the natural world

NEED

B.2 Describe the need that the proposed project/program seeks to address. Include data supporting the need.

Recommendations below from NC OAP & 2020 NC SHIP demonstrate the need:

- * Improve access to drug treatment programs, including medication-assisted treatment (MAT).
- * Increase the number of people that receive SUD treatment & recovery supports.
- * Expand use of evidence-based & emerging treatment methods for full range of SUD, including stimulant use.
- * Ensure substance use treatment utilizes evidence-based principles following ASAM model, e.g., includes access to medications to treat SUD, does not require failure at abstinence before receiving MOUD, prevent people from being discharged from treatment for continued substance use.

Forsyth County drug overdose deaths increased between 2021 & 2022 from 149 to 181 deaths per year. Approx 38% of these deaths are women, which equates to @ 68 women last year. Deaths are the tip of the iceberg when measuring prevalence of SUD in an area.



ITW is unique, there's nothing like it within 150 miles. It is for women only. Accordingly, all programming is female-centered, which necessitates a trauma informed approach. Our program is free of charge for those with an inability to pay &/or are uninsured. We welcome women on MAT for opioid dependency - not common in the treatment field, most facilities require total abstinence for admission.

COLLABORATION

B.3 Describe any specific collaborative relationships with other organizations including agencies and organizations you routinely refer to (public or private). How will collaboration contribute to the planning, implementation, operation, oversight, and performance measurement of the proposed project/program?

We work closely with Advancing Forward Health, a patient centered clinic that provides medical management and counseling to those suffering from opioid use disorder. Their Board-Certified Addiction Medical Physician, Dr. Levin, provides no charge/in-kind medical assessments for each ITW applicant, acts as a medical consultant to our Board and participates in ITW activities when time permits. Dr. Levin's addiction medicine experience and expertise is critical to our program and offers us the support and assurance we need to successfully work with those on MAT.

We also recieve a number of referrals from Advancing Forward Health, the DATA (District Attorney Treatment Alternative) program, the Hawley House (halfway house for women recovering from SUD), and Pathways to Self-Reliance.

At the end of each session the women complete a 10-question evaluation in which they rank themselves on a 1-5 scale (1 (never), 2 (rarely), 3 (sometimes), 4 (Often), 5 (Always)) pre and post IOP.

70% of women will rate 5 qualitative measurements post IOP at least 2 points higher than they did pre IOP.

MISSION

Into the Wild (ITW) provides a transformative adventure recovery intensive outpatient program designed specifically to support women on their journey to recovery from substance use disorder (SUD). We understand the compounding and debilitating effects trauma and substance use have on women. Our unique, non-classroom approach aims to integrate mind, body, and spirit through the power of nature, movement and traditional evidence-based practices.

Our staff is uniquely qualified to provide this program. Sonia Hensel, ITW Executive Director, has B.A. in sociology from Salem College, is Licensed Clinical Addictions Specialist, Certified Clinical Trauma Specialist & holds master's degree in counseling. She has 25+ years' experience working with women suffering with SUD. Certified wilderness leader & yoga instructor. Her passion lies in creating & facilitating empowering outdoor activities for women.

Dr. Laura Levin has been a pediatrician for over 30 years. In 2014, they fell in love with addiction medicine as a way to treat opiate use disorder & became Board Certified in Addiction Medicine. They provide medical assessments for each client prior to participation. They also act as our Medical Consultant on the Board.

ITW Art Therapist, Diane Greene, is an award-winning multimedia artist & documentarian who uses inquiry & artistry to capture particular moments of human condition, blending themes of community, place, identity, emotion, and memory to create unique opportunities for creative self-expression for our clients.

Into the Wild's healing space is located on 35 wooded acres with a lake for adventure recovery water activities, a dock for meditation and gentle yoga, trails for hiking and much more. Each 6-week program meets 2 days a week, 5 hours each day. Each day includes approximately:

- * 60-75 minutes of Group therapy, daily Check-ins, & Recovery Related Education Modules
- * 45 minutes self-regulation practices, e.g., yoga, meditation, breathing and other mindfulness practices
- * 90-120 minutes of adventure/experiential activity which can be anything from hiking to disc golf, to kayaking/paddleboarding, to art therapy, and more
- * 60 minutes for breakfast and lunch/meal prep lesson.

D.2. How does the proposed project/program help advance the mission of your organization?

Because we are asking for funds for operating expenses for Into the Wild, the funds will only be used to advance our mission.

ITW provides a transformative adventure recovery intensive outpatient program designed specifically to support women on their journey to recovery from substance use disorder (SUD). Adventure recovery is an innovative approach that Printed By: Joanna Kelly on 9/28/2023



utilizes outdoor activities and experiential learning to promote personal growth, self-discovery, and healing. These activities, combined with other evidence-based and trauma-informed therapy, provide a unique and powerfully effective approach to treating those with SUD.

Below is a list of selected benefits of an adventure recovery/therapy approach for those struggling with SUD. These benefits advance and demonstrate the transformative nature of our program as stated in our mission:

- * Provides hands-on, real-life experiences that challenge participants which facilitates learning & personal insights in ways traditional talk therapy often can not achieve.
- * Presents individuals with challenges that require problem-solving, adaptability, & resilience. Overcoming these boosts self-esteem & confidence crucial for recovery.
- * Nature has calming/grounding effect, proven to reduce stress, anxiety, & depression (often co-occurring issues with SUD).
- * Encourages participants to step out of comfort zones, promoting emotional expression & vulnerability. Sharing feelings & experiences in supportive group setting fosters sense of belonging & connection.
- * Encourages self-reflection examination of thoughts, feelings, & behaviors which lead to deeper understanding of factors contributing to substance use & pave way for change.
- * Develop & practice healthy coping strategies. Instead of turning to substances to cope with stress or emotions, individuals learn to manage challenges in a constructive manner.
- * Redefine self-concept. Women begin to see themselves as capable, strong, & resilient individuals, which contrasts with the negative self-image often associated with addiction.

FUNCTION

D.3. How does your organization currently benefit and serve Forsyth County and its residents?

We specifically serve & benefit women in Forsyth County, especially those on MOUD, with low/no income &/or no insurance.

When it comes to women, we must consider the extensive & powerful ripple effects observed when they recover — they reach far beyond the individual. This is especially observed in family relationships. Women often play central roles in families. Their recovery has a profound impact, especially on their children. Recovering mothers provide the opportunity to break the cycle of intergenerational substance abuse.

ITW provides a female-centered approach. We prioritize somatic self-regulation practices, e.g., meditation, yoga, breathing exercises. These are not simply gratuitous feel-good practices – these are game changers. Self-regulation practices provide practical coping strategies critically necessary for those with SUD. Use of substances was the primary means of coping prior to recovery.

Physical & sexual trauma (which 89%+ women with SUD have experienced) is held in & released through the body. These women are often detached from their bodies. These practices provide safe avenues to reconnect with themselves. This is also why we focus on nutritional/healthy eating; physical health has not normally been a top priority. For all these reasons, experiential, physical & body-centered approaches like adventure therapy & self-regulation practices are critical to women's recovery. Our approach is an all-encompassing, holistic one.

D.4. Please provide your agency's community impact or expected community impact with providing the proposed program or service.

The current community impact is limited by the number of cohorts we can provide each year & number of women we can have in each cohort. At our current level 36 is likely the most women we could serve next year, which coincidentally is almost half of the approximate 68 women who died of a drug overdose last year. If those women could have gone



through our IOP, they likely wouldn't be dead now. That would be significant impact.

Though our current scope is limited, this is just the beginning. The need is so great & response to our work so overwhelmingly positive, we must scale up! Here are just 2 comments from post IOP evaluations:

"This has changed my relationship with myself, and that has changed my life."

As of Aug 2023 opioid overdose ED visits were up by 28% compared to Aug 2022. What we are doing is not working. ITW provides an innovative approach that is not the same old "whiteboard" classroom treatment approach. At ITW we treat the whole person.

Ultimately, with increased community investment, we foresee this program becoming a residential, year-round program in which we could serve 100+ women a year (& possibly men). We envision ITW being a draw for the Triad area and beyond. It is the only program like it within 150 miles. It meets a critical unmet need in FC (and NC in general).

D.5. Client Eligibility Requirements: How are participants declared eligible to participate in this program?

Any woman with a substance use disorder who wants to recover is welcome to apply. Women must not be actively using drugs/alcohol. There is no rule on how long someone must be clean/sober to attend, but they must be medically stable and physically able to participate in the program. We do not provide medical treatment. Alcohol/Drug withdrawal issues need to be addressed prior to admission via detox, MAT, etc.

Each applicant completes a medical assessment with our Addiction Medicine Physician, Dr. Levin, and a psychosocial assessment with the Executive Director to ensure there are no mental or physical conditions that would preclude someone from being able to participate and benefit from the program.

D.6. Program Fee Structure: How much do participants pay to participate in this program?

At this time, participants attend our program free of charge.

Currently this policy is under review. We intend never to turn anyone away for lack of funds, but we also know that if folks could contribute, even a small amount, it can have a strong psychological impact on their level of commitment.

We will likely implement a sliding fee scale in the future while allowing those who cannot contribute to attend at no charge. We're talking about as little as \$10-20 a week, \$100 total - something like that (or of course, more if they can afford it).

- * District Attorney Treatment Alternative (DATA): a criminal justice diversionary program whereupon successful completion of program requirements, which includes an IOP program, the District Attorney's office agrees to take a voluntary dismissal or a reduction of charges.
- * Pathways to Self-Reliance is a woman-owned and minority-operated business who serve individuals with mental health, developmental disabilities, addiction and substance abuse illnesses.
- * The YWCA Hawley House is the only state-licensed recovery halfway house in Forsyth County for women diagnosed with Substance Use Disorder.
- * Advancing Forward provides medication assisted treatment for those with an opioid use disorder. Their business model offers low cost, compassionate and convenient care.

These organizations work with some of the most marginalized and underserved groups in our community, for example those involved with the criminal justice system and those who generally have no other housing options than to live at a halfway house. 90% of our participants are low-income.

SUSTAINABILITY

E.7. Describe the plan to sustain the project/program funding in future years. Include information about other funding sources to leverage County funds requested.

We believe once we have a full 2-3 year program history we will be able to access the wealth of funding available from local, state and federal grants aimed at addressing opioid/drug addiction crisis we facet today. We foresee these being critical funding sources for a good 5 plus years (or more). In time, we hope they will play a significant role in expanding our program to a residential year-round treatment facility.

We think the WS Foundation and Women's Fund will be instrumental in that regard as well. We received high praise for our program previously from the Women's Fund, which did not actualize into a grant, but we are encouraged it will in the future.



We plan to be medicaid/medicare reimburseable next year. Though many of your clients have no insurance, approximately 30% do.

We will begin a sliding scale fee for our program, which is unlikely generate significant income initially, but will increase as we expand and increase our numbers in the future.

Once we are able to provide residential, year-round programming we feel certain our unique, innovative IOP will become a regional draw. With that, we will attract clients who have personal insurance that can pay for treatment.

We intend never to turn people away that cannot afford treatment, but we will find creative ways to offset those costs.

We are in the process of brainstorming creative fundraising ideas that incorporate adventure therapy opportunities for the general public to experience, e.g., a day of yoga & art, an overnight backpacking trip.

BARRIERS

Describe any potential programmatic or institutional barriers to project implementation (e.g. staff vacancies, pending departures, challenges with connecting with the target population) and your plans for overcoming them. Scheduling treatment is challenging. If an Into the Wild IOP is not available at the time or soon after the person is "ready" and/or available for treatment, it's likely that person will have moved on in some way by the time the next one comes around, e.g., gotten a job that limits their availability.

Because we are a newer organization we are figuring learning as we go. We know to over enroll folks in the program. We may start out with 10 and end with 6. We think having people make a financial contribution to the program could increase commitment levels.

Our most significant barrier by far is funding. We have the staff, the space, the equipment and the women, we just struggle to find funding. It's frustrating. For private foundations (and the general public/individual donors) we can't help but think the lack of investment relates to the intense stigma surrounding those with SUD, especially women with SUD. That contributes to the rationale as to why we are considering emphasizing the "adventure" aspect of our program to attract donors. If we can demonstrate to regular folks the incredibly beneficial results/outcomes/nature (incredible benefits) of participating in these activities, perhaps that could translate to them wanting that same experience for others, especially those that are struggling.
