What is supervised contact?

Supervised contact is the time a non-residential parent spends with their child and takes place in the presence of an independent person.

The supervision can take place at changeover, or for the entire visit.

Supervised contact is child focused. The main benefit of Supervised Contact is to provide a safe and secure space for the child to spend time with the non-residential parent.

The meaning of supervision is that the nonresidential parent and child are free to spend time together, and allows regular contact, in a friendly environment where the child can seek assistance if they become upset or fearful, and where a supervisor can intervene at any time should the need arise.
