

What is a Parenting Orders Program?

A Parenting Orders Program (also known as Post Separation Parenting Program) is under the Family Law Act. It helps separated parents learn how to work out arrangements that allow other parents and family members to spend time with their children.

Why go to a Parenting Orders Program?

At times, families who are separated are not able to agree with arrangements for seeing their children and cannot make parenting orders work. Parents may have been to court to have parenting orders made but have trouble complying to the orders. A Parenting Orders Program helps parents understand what children need and want at different stages and ages of their development.

A Parenting Orders Program can be referred by the courts or you can attend this program on your own or together.

What happens during a Parenting Orders Program?

Who it is for?

What if you are feeling unsafe?

The facilitator will have arrangements in place to protect both client and staff. Please let us know as soon as possible.

Is what I say confidential?

Yes, under the Family Law Act, everything you say remains confidential – except in cases of serious threat of harm to others or yourself. The facilitator must report child abuse or risk of abuse to the appropriate authorities, which include, The Department of Child Safety, Police, your legal representatives (if applicable) and the Independent Children's Lawyer (if applicable)

What are the main benefits?
