    - i. 1.8% = \$446.31/month new dues effective January 1, 2017
    - ii. 1.6% = \$396.72/month new dues effective January 1, 2017
  - c. Ballot results of Security cameras proposal = <80% response rate received. There are a total of 60 units and 48 units must vote "Yes" to pass proposal. Ballots will be re-sent to the owners of units a response was not received prior to the annual meeting in December 2016.

  - a. Bids for caulking exterior of building Spring timeframe
  - b. Landscaping around the driveway sign Table till Spring timeframe. Bids being obtained
  - c. Roof Pavers above unit 400 Table till Spring timeframe. Apparently, water does not drain off roof appropriately. Will look at long-term solution.
  - d. Main water valves in units Table for two months. All floors completed except 1<sup>st</sup> floor units.
  - e. Lobby remodeling. Apparently, painting contractor discovered some mold on an exterior wall when the wall paper was removed. The mold was appropriately treated prior to painting primer being applied. Overall, the project is going well. Walls will have a paint primer and then a final paint finish.
